REVISION 2016

The beginning of the management of the new CA after the Sao Paulo congress (August 2016) was complicated by several factors:

On the one hand, due to the letter received from the Belgian colleague in which he questioned the validation of the vote for the election of the new CA .. We resorted to the firm Del Sol and Jean BAUTRIC on the interpretation of the statutes and the resignation of the company French family therapy.

Then we drafted with the Board of Representatives on December 4, 2016, an open letter to the members of the AIPCF answering the questions posed (voted unanimously by the CA of 11.12.16, with one abstention).

The interpretation of the statutes is not the result of chance, but responds to a political conception that allows or not to regulate the power systems inherent in any work group.

Two conceptions are at stake:

Or we tend to balance power between different languages and currents of thought;

Or we tend to concentrate power in the hands of a small number of people in a single country.

On the other hand, in this first stage, we also had to manage with the prefecture the issue of the association's headquarters whose address was included in the statutes illegally. Then we made our declaration to the region of Auvergne Rhône Alpes and got the receipt of this on the modification of the address of the new headquarters of the association in: 24 rue Auguste Comte in Lyon.

One of the difficulties encountered was that the leadership of the first president was in the bylaws which implied following the steps of the prefecture and which took a long time.

In addition, the recovery of the domain name of the website was the subject of a long work. First, we had to negotiate with the hosts of the old website to retrieve the ownership of the domain name that proved to be fundamental for the association and for the statistics already accumulated.

The company, in response to this long process, gave us the administrator access codes. It was possible to make a contractual termination with Stéphane LORION. Finally, on May 22, 2017, we had the transfer of the site to a new host.

About the design of the new site, after comparing the proposals of 4 webmasters in a comparative table of offers, we started to redo the website, which took several months. The general and joint work between the webmaster of Mr. Gilles GUIAS, the Board, the Board of Directors, the secretariat team and myself with the collaboration of different colleagues for the translations and, in particular the Romanian colleagues, as well as the availability of the works of the painter Elizabeth SKORKA, allowed us to elaborate the final proposal of the new site that the CA approved.

BALANCE 2017 SCIENTIFIC ACTIONS

1. IPA-APM Congress

We were invited by IPA to participate as speakers at the II International Congress of Psychoanalysis of Couple and Family, organized by the IPA and the Psychoanalytic Association of Madrid. With the theme "Perspectives around the world" was held in Madrid in February 2017. The AIPCF was represented by Juan GONZALES, Rosa JAITIN and Carles PEREZ TES

2. European Regional Conference of the AIPCF - AEIPPS

We organized jointly with the AEIPPS of Madrid, the European Regional Conference "Family Secrets in Psychoanalytic Family Therapy", on June 16-17 with the participation of N.

I would like to point out that this is the first time since the beginning of the association that the Regional Days have been financed by the local association with an income for the AIPCF. THE BOARD OF DIRECTORS

1. We have started to elaborate an internal regulation to define the new framework for the operation of the AIPCF ADMINISTRATIVE COUNCIL

All agencies of the AIPCF must send a schedule of their meetings at the end of the year that ends so that the General Secretariat can prepare the general schedule of the AIPCF.

The hours of Internet meetings should take into account the time differences of all member countries, to facilitate participation in meetings.

The working documents must be previously sent to the Board and must be read by all CA members to be voted by email or during meetings.

The frequency is 4 meetings per year.

2. The modification of the Member Category is voted unanimously

AGREEMENT REVIEW - OFFICE

We held a meeting in Rome to analyse key issues for the development of the review. Carles and Rosa Jaitin by the Bureau and Daniela Lucarelli, Director of the review AIPCF and Massimiliano Sommantico, Chief Editor.

It was a friendly meeting and we particularly appreciate the hospitality with which Daniela Lucarelli received us.

We have synthesised the central points of our exchange:

- Daniela Lucarelli is the director of the review and Massimiliano Sommantico is the editor.
- For each issue, 3 editors from different languages will be appointed.
- Agnès Rotschi, copywriting secretary in various French magazines, will share the writing with Francesca Enuncio. Agnès Rotschi will take care of the French part and Francesca Enuncio will take care of Spanish and English. The budget item will be divided: 33% Agnes and 66% Francesca. Interested parties will be consulted and they will have to share overall working criteria.
- For personal reasons, David Levisky does not wish to continue in the Editorial Board and Henri-Pierre Bass cannot continue because he has been appointed Editor-in-Chief of the RPPG Review; and he therefore suggest to Cristophe Bitollo to replace the French language.
- Given the difficulty of continuing with the dictionary in a trilingual version in the review, it is suggested to think about the publication of the dictionary in book format.
- Evaluation of the review's budget. At the beginning of the school year, we will suggest to the Board an increase of the membership fee with a percentage for the review.
- It was agreed to suggest to the Board and the General Assembly to take the necessary steps to index the review:

Step 1: Register for the International DOI Foundation "and contract the DOI for the next issue of the review 2nd step: to be indexed by PsyInfo

3rd step: to be recognised by SCOPUS

Step 4: Be indexed by Web of Science (Thompson Reuters).

This indexing is vital for the future of psychoanalysis at the university, that is to say, the pursuit of research.
