## PRESENTATION OF THE THIRD ISSUE

Dear colleagues,

We are pleased to present Tramas Bulletin No. 3, which is the means of disseminating all the scientific and administrative activities of our Association.

We are going through an uncertain period and unexpected situations are arising. In this context, the IACFP must leave a blank page in order to formulate questions that open the way to in-depth questions, reflections and debates.

In order to move forward in our institutional development, we need to rediscover our origins and look back at the reasons why our association was founded. This will allow us to reassert our identity and open up debates to avoid its alienation and allow for its permanent recovery.

The IACFP was created to bring together colleagues trained in couple and family psychoanalysis from different associations throughout the world, with the aim of creating a space for reflection that brings together the different approaches to couple and family psychoanalysis, outside of any supra-associative supervision.

Today we are at a more advanced stage, because after 20 years great theoretical and clinical progress has been made in our field.

The first challenge to psychoanalysis was taken up by child psychoanalysts.

Today it is our field that has taken up the challenge of widening the scope of psychoanalysis, especially by developing it within health institutions. We need to work to breathe new life into psychoanalysis, and to join forces to address the loss of influence of psychoanalysis in the scientific field.

Several questions arise:

- How is it possible that the current trends in the world, leading to authoritarianism and unrest, permeate our institution under the influence of various forms of destructive and self-destructive violence?
- How can we counter the death drive through scientific and cultural productions in which music, cinema, theatre and poetry act as connecting mediators?
- Responses to new clinical challenges will allow us to analyse the effects of the scopical drive and the drive to dominate and transform them into the drive for life
- Will the IACFP continue to create and support small clinical and research reflection groups to work on issues specific to each country and region of the world?

Can this newsletter be a source of support and respect for differences without succumbing to hegemonic thinking?

The debate is open.

As an introduction to this number 3:

Anna Nicolo's letter brings you up to date with the many new activities of the Association, including English, French and Spanish-Portuguese days. She also outlines plans for our International Congress to be held in Guadalajara, Mexico, in 2026.

Below is the report by Cristina Calarasanu (Romania) on the new structure of the Scientific Council and the committees responsible for organising the Scientific Days in the three languages.

We will present the evolution of the activities of the Study Centre, which is a future space for our scientific work, in accordance with the Scientific Council and the Board of Directors of the IACFP. ([www.aipcf.net/centro-de-estudio](http://www.aipcf.net/centro-de-estudio)).

The activities are divided into different poles:

1. Clinical and research groups led by colleagues from Argentina, Colombia, Spain, France, Israel and Peru. These groups are open to anyone interested in participating or proposing other topics ([centre.etudes@gmail.com](mailto:centre.etudes@gmail.com)).
2. We have created the Bibliography Section, coordinated by Luis Armando Gonzales (Mexico) and Patricia Alcalde (Peru). After several meetings, we have received advice from the librarians of the Argentine Association of Psychoanalysis of Buenos Aires, the Argentine Psychoanalytic Association and the Argentine Association of Psychology and Group Psychotherapy.  
We will soon send you the criteria for presenting the bibliography. We look forward to your collaboration in updating this bibliographical collection.
3. The coordination between the Study Centre and the IACFP Journal is assured by Anne Loncan.
4. The International Journal Network, coordinated by Rosa Jaitin (France) in collaboration with Liliana Levy (Argentina), Anne Loncan (France) and Hana Salaam Abdel Malek (Lebanon), has included innovations such as the creation of writing workshops to encourage IACFP members to write articles with a view to publication.

Another innovation is the opening of a writing group to study the impact of artificial intelligence in the field.

You will also find news from the journals associated with our network and the activities and conferences that concern us.

## LETTER FROM THE PRESIDENT OF IACFP

Dear colleagues,

I have informed you on several occasions, on the website and at the General Assembly, of the changes we have proposed to the organisation of our association.

I cannot deny that it has been and continues to be a difficult and complex task, which has produced results in some areas, while others remain problematic. It is exhausting to renew an association like ours, which has many voices and many sectors. It is necessary to overcome mistrust, to change acquired positions, to gain the trust of many and to increase the number of those who work in it and contribute new ideas. Certainly, at the scientific level, the inclusion of three subcommittees in French, Spanish and English has been a success, with the creation of a new scientific activity: clinical days, one per language and in different countries. The aim of this activity is to stimulate scientific interest and activity in different parts of the world, with contributions from old and new colleagues.

Other areas are more problematic, such as defining and increasing membership. Maintaining the participation of former members is very important. There are new members from Peru, Russia and Italy, while the confirmation of former members is problematic and slow.

It is surprising to note that it is the French-speaking, English-speaking and Argentinean colleagues who have gradually disappeared, abandoning the association they helped to create. The reason for this behaviour is partly unclear, partly linked to old ways of working. We can assume that for some the renewal of membership was taken for granted, like an old custom that encourages not to renew because membership is taken for granted. For others, the commitment required was a financial burden. This is one of the reasons that convinced us to reduce the cost of membership. We can also think that our association should strive to make research and exchange accessible to all, so that it becomes the property of all and an increasingly shared object. A scientific society in which the same people always work and speak becomes sterile and gradually dies. That is why we need to create a place where different people and models can confront each other, stimulating cross-fertilisation between members and ideas. If this does not happen, and if someone sees his own model of work and thought as a source of truth to be transmitted to followers, there is a very high risk that our organisational structure will become increasingly sterile and lead us into a dead end.

The need to deal with these various difficulties is at the root of the changes we have proposed, which are articulated in several directions. First of all, we will soon see the creation of a new website that will bear witness to the activities of the Society, inform everyone and facilitate participation. . The webmaster, Carlos Marchese, keeps telling me that he will soon show us the new look of the site, which we have partially agreed with him.

The next International Congress will be held in Guadalajara, Mexico, in 2026 , with the theme 'Psychoanalysis in the face of current configurations of couples and families'.

The titles and dates of the regional clinical sessions will be announced in this newsletter by Cristina Calarasanu. We are living through a difficult year in which wars, massacres and migrations are radically changing our world. The theme of the Congress has been specifically chosen to question us about the social and individual changes that characterise our world.

The Scientific Committee of the Congress will question us on pressing issues. In my opinion, couple and family psychoanalysts are among the most involved scholars in the discussion of the changes in the form of families and couples today, with particular attention to the new forms of the Oedipus complex, single parenthood, homogeneity and fatherhood or motherhood in reconstituted families. Today we are witnessing the problems of adolescents, with an increase in suicide attempts and, at least in Western societies, bullying at school, violence and the problems posed by gender inconsistencies, all of which could be considered 'psychosocial syndromes', testifying to a different configuration of relationships between the individual and the family, the group and social functioning.

While maintaining continuity with the past, we need to renew the theories with which we view families, couples and individuals. To what extent do the ideas and models with which we were formed resist the impact of time, to what extent are they useful for explaining and intervening in what is happening?

The IACFP may be a melting pot of theories and interventions, but we must renew the hope that we have all invested in its birth and in the scientific, organisational and economic effort that each of us has made.

## **Who**

20 members of the Scientific Council were present.

The meeting was opened by the Scientific Secretary who presented the new structure of the Scientific Council and its objectives for 2023-2025. The President of the IACFP then took the floor to inform the Scientific Council about the scientific activities of the Association and the upcoming Congress.

## **Regional days**

The three commissions gave brief presentations on their activities and the state of organisation of the regional conferences.

Pierre Benghozi gave an update on the French-speaking Commission. The conference will take place on 12 October in Bordeaux, in the Salle de la Maison Cantonale, in person and by videoconference. It will be an afternoon session, from 14:00 to 21:00, on the theme 'Violence in and against the family'.

The programme will include several round tables on different topics. The event is organised with the support of APSYFA (Association Psychanalytique des Thérapeutes Familiaux d'Aquitaine). The brochure of the event was presented to the CC.

On behalf of the Spanish-Portuguese Commission, Ezéquiél Jaroslavski and Manuela Porto presented the conference. It will take place on 29 and 30 November, from 15.00 to 20.00 (Spanish time), by videoconference, on the theme 'Contemporary Clinic for Couples and Families'. The two-day structure was necessary to take into account the different regions of South America and the different time zones. Each day will include clinical material (couple and family), speakers, small discussion groups and a round table. The day will be opened by the President of the IACFP and closed by the Scientific Secretary.

There is a problem with translation from Spanish to Portuguese and they are working on solutions. A brochure will be available shortly.

For the English-speaking Commission, in the absence of Hanni Man Shalvi, the coordinator, Anastasia Tsmaparli, announces the conference to be held in London on 6-7 June 2025 (in person and by videoconference in collaboration with Tavistock) on 'Working Psychoanalytically with Couples and Families in Turbulent Times'. English-speaking colleagues from Europe and North America, India and Australia will be invited. Organisation is underway and more information will be forthcoming.

### **The International Congress of 2026**

The Scientific Secretary has announced that the International Congress will be held in Guadalajara, Mexico. We are delighted to be working with colleagues from the Guadalajara Psychoanalytic Association. A local committee has been formed. They are in talks with two private universities to find a venue for the congress.

According to the CS proposals, the congress will be held in 2026

A draft of the brochure was shown to the CC and several suggestions were made. Luis Armando González will work with the webmaster to produce a final version.

The last part of the discussion was about the title. We need a shorter and more memorable title and a subtitle. Several suggestions were made: Links between Challenge and Creativity, Links between Turbulence, Diversity and Creativity, Diversity and Turbulence, New Ways of Creating Couples and Families, Couples and Families in Transformation, etc.

The scientific secretary studied the proposals and suggested the final title 'Making a couple and a family today'. Psychoanalysis in the face of new configurations'.

She also announced that she would send a draft of the argument to the coordinators of the three commissions, which would then be worked on by each commission.

A second meeting of the full Scientific Council will take place at the end of the year.

# STUDY CENTRE

The IACFP Study Centre is a prospective space for the scientific work of the AIPFP.

The Study Centre (SC) operates under the coordination of its Director, appointed by the CA with the approval of the CC.

The results are presented at conferences, published and disseminated by the Association.

The IACFP Research Centre has several scientific production centres. Each centre has a person in charge.

## **1. WORKING GROUPS Responsible: Rosa JAITIN Secretary: Felisa PERRY**

The Research Centre (EC) collaborates in the organisation of research groups linked to universities and clinical focus groups in relation to the Scientific Council.

There are two types of working groups:

- The reflection groups

- The Board of Directors, in agreement with the CC and the CA, proposes the creation of a Research Centre to centralise the scientific contributions of each of its members. This research centre will encourage the creation of working groups among its members.

The Working Groups will be organised around a task defined by their own members and will elect a spokesperson who will act as coordinator of the group.

There are two types of working groups

Theoretical-Clinical Reflection Group Research Group Theoretical-Clinical Groups propose group work, both theoretical and clinical, on a specific task through reflective discussion, readings, group dynamics and personal experience. In this way, members explore the proposed topic in depth and come to their own conclusions.

These reflection groups require a minimum of three participants and may meet in person, directly virtually or indirectly virtually.

The focus of the reflection groups is on the task and the relational functioning of the materials to be worked on. The aim is to analyse the clinical material in terms of transference, countertransference and intertransference.

Scientific research groups are a group of people who meet to carry out research on a specific topic.

They formulate objectives and hypotheses, define a scientific methodology (quantitative or qualitative) and draw up a medium- and long-term strategic plan to work on. In this way, they produce knowledge on the subject in question.

## STUDY CENTRE

A research group is made up of at least 3 people who work deliberately on a plan, purpose or agenda organised by research projects and programmes for a period of time sufficient to produce knowledge outcomes.

The purpose of this work is to achieve quality results that are relevant and visible. This work aims to achieve tangible and verifiable results that meet the objectives set, as a result of projects and other research activities that are appropriately expressed in a duly formalised plan of action (projects). Each of these activities is recorded in the curriculum of each researcher and then in the research group.

The results of the work of the reflection and research groups will be presented at conferences and may be published in the journal.

All IACFP members are welcome to participate in these groups and new lines of work can be proposed.

Proposal for the organisation of the groups by the coordinators:

Each group will hold 4 annual meetings of 2 hours each for 2 years to present at conferences, plan the dates of the meetings with the links and send them to the Study Centre for publication on the web.

Presentations:

Each group will present their progress at the Study Centre meetings and their overall conclusions will be presented at the IACFP International Congresses (twice a year). Partial progress will be published in the Tramas Bulletin and new members can request to join the groups of interest to them.

### **2. The BIBLIOGRAPHY RESPONSIBLE: Luis Armando GONZALEZ – Patricia ALCALDE**

A commission, coordinated by Luis Armando Gonzalez (Mexico) in collaboration with Patricia Alcalde (Peru), has been set up to coordinate this centre.

The Commission is currently composed of Anne Loncan, Hana Salaam Abdel-Malek and Carlos Marchese, and we will add other representatives, taking into account the plurality of languages, to collaborate in the work of systematising and updating the data. They will follow the international criteria of the APA, giving space to our members and universities.

The EC is developing criteria for the systematisation of the international bibliography, organised in the form of a list of bibliographical data that can be continuously updated, taking into account the plurality of languages of the IACFP.

We are advised by the librarians of the Argentine Association of Psychoanalysis of Buenos Aires, the Argentine Psychoanalytic Association and the Argentine Association of Psychology and Group Psychotherapy.

We have an agreement with the Virtual Library of Psychoanalysis (BiviPsi), which makes bibliographic consultation and access to texts available to all our members

The Study Centre plays a key role in promoting academic collaboration and research, working in close partnership with universities and the Scientific Council. One of the key initiatives is the organisation of clinical and research reflection groups, which serve as spaces for the exchange of knowledge and experience between professionals and academics.

These working groups are set up around a specific task selected and defined by their members. This autonomy allows participants to address topics of common interest and relevant clinical challenges. Through their choice of focus, each group makes a significant contribution to research and the development of best practice in their field. In addition to the task, groups are encouraged to appoint a spokesperson to act as team coordinator. The spokesperson plays an essential role in facilitating communication and coordinating efforts within the group.

# Clinical Working Groups

## **“Relationship psychoanalysis by Isidoro Berenstein and Janine Puget” (group report 2023-24)**

At the bimonthly meetings in 2023 and 2024 brought together members from 6 countries on 3 continents for fruitful presentations and exchanges.

The theoretical and clinical topics worked on were Paradigm shift with the relational and its theoretical-clinical implications, community interventions, decolonisation of the unconscious, relational complex, radical novelty.

On the singularity of Isidoro Berenstein and Janine Puget's thinking on the relational:

They make a cut, an epistemological change. No longer from the Cartesian dichotomy, nor from Newtonian physics, but from the logic of complexity, quantum physics and contemporary philosophers. Their conceptualisation of the relational includes the logics of the two (representation) and the one (representation). Heterologous logics that coexist in a superimposed, discontinuous and unarticulated form, both in life and in the session.

This other metapsychology they propose requires a different clinic, with new tools such as interfering – intervening, in addition to interpreting.

Connecting means leaving the logic of identity. It is movement and production, 'becoming, becoming with others and in every situation', in continuous processes of subjectivation.

In addition, there has been work on social subjectivity, conceived as a result of the effects and impacts produced by belonging to and experiencing social-political-cultural-environmental-institutional spaces, both local, national and global.

Our meetings accommodate the expression of these effects in the members of the group, who are confronted with current, shocking, confusing and disempowering situations. The Link proposes to inhabit these situations: to think and act in the present, with and among others, in the future, in fluidity. It is a work to be done as subjects in order to be able to undertake our clinical interventions.

## Clinical Working Groups

### **Threesomes: new configurations of the couple bond - Changes in the ways of being a couple (2024)**

The magma of social imaginary meanings regulates the discourses, practices, desires and feelings that constitute the subjectivities belonging to a society at a given time. The changes and transformations that the new realities of being, being and relating in the 21st century are presenting us with affect the couple as a social institution in constant movement and transformation. Psychoanalysis, and in particular the relational perspective in psychoanalysis, provides us with tools to rethink theories and reformulate practices that we are experiencing in our clinic.

'Social work with couples and families'.

It is a free and voluntary space for vulnerable groups in Peru. A meeting based on solidarity, attachment and affection is held through 3 facilities supported by 25 therapists: Shelter in Abancay (Peruvian mountains). San Columbano School in the San Martín de Porras district of Lima, Listening Line.



# Clinical Working Groups

## Multi-Family Therapy (2019-2024)

In 2019, we launched an online group for the study and reflection of multi-family groups (MFG). This group was made up of a dozen professionals (psychologists and psychiatrists) from different countries (Spain, Portugal, France and Russia), with internships in different public and private institutions. Most of them had no experience in this type of activity.

The meetings take place every two months and last two hours. The work is based on the concepts of J. García Badaracco, who began with this therapeutic tool in a psychiatric hospital in the city of Buenos Aires in 1960. The work in this modality tries to study its specificity and to differentiate it from other therapeutic spaces (group therapy, family therapy, attachment therapy, etc.). In these 4 years of existence we have dealt with theoretical and clinical aspects of the activity and we continue in this line of work.

Following the participation of our Association of Psychoanalytic Psychotherapy for Couples, Families and Multi-Family Groups (APyF) in a research project sponsored by the European Union on 'Multi-Family Groups in Mental Health', together with Italy, Portugal and Belgium, we have developed 4 products:

A GUIDE on GMF, in terms of their distribution and characteristics of these groups in the 4 countries. Where we observe a clear predominance of the García Badaracco model.

A VADEMECUM on the basic concepts of multifamily psychoanalysis (theoretical, technical and curative).

The COMPETENCES that a group leader of this type must have.

A TRAINING PROGRAMME with three levels: facilitator, driver and expert driver.

It was also completed with an international bibliography on this activity.

Last year the Vademecum was distributed and this year we are working on it and the clinical material as a form of supervision that will be presented.

The group is open to anyone who wants to join. We think we can reach 20 participants.

# Clinical Working Groups

## Pandemic COVID (2020-2023)

The group has been working for 4 years and will start its fifth year in 2023. It currently consists of 15 members and has grown from 11 to 15 members this year.

Through surveys, interviews, meeting materials, conversations, data studies, statistics and our own personal and professional experiences, we want to explore how this process has affected us and continues to affect us. Using a reflection group system, we will be able to ask ourselves about the different aspects that this phenomenon has presented and is presenting in the clinic, trying to explore issues that have not been sufficiently taken into account in public policies in terms of mental health. The main idea is to be able to contribute our knowledge and offer some help to health services in the form of advice and writings, reviewing what has happened and is happening to families, couples and the community in general in the different countries of the world, and how to be better prepared to face other scourges of this kind.

During the first meeting of the year, held on Thursday 30th March, new members were welcomed, a few words were said in memory of Eduardo Grinspon, who died in December 2002, organisational matters were discussed and Donatella Lisciotto's clinical experience of the Covid pandemic was listened to and shared.

We held three meetings during the year with excellent participation from its members (Mariagrazia Giachin - Donatella Lisciotto - Barbara Bianchini - Fabrizia Giusti - Graciela Consoli - Manuel Liss - Rocío Cabanzo - Ondina Greco - Giuliana Marin - Susana Casaurang - Fiorenza Milano - Manuela Porto - Tatiana Páez Sanguinetti and Irma Morosini).

The dynamic during the year was to invite colleagues, both members of the group and guests, to speak about their experiences and reflections during the pandemic process.

Dr Donatella Lisciotto spoke at the first meeting, Dr Alejandro Klein at the next and Dr Osvaldo Bodni at the last. The last two were invited by the coordinator.

Ideas emerged from the exchanges and it was suggested that we broaden the theme that occupies the group by working on the situations that challenge us in our daily lives, epochal changes and their effects on our subjectivity, including the pandemic and its effects. We will continue to work on these ideas in 2024.

Three meetings are planned for the year (18/April - 11/July and 14/November). In the following meetings (7 of September ; 14 of December), the Coordination plans to invite other professionals to share their experiences and ideas, with the aim of exchanging and writing about them in a joint work like the one presented at the last IACFP Congress and published in the Journal.

## Research Groups

### **Research: Projective tools for family and institutional groups (2024)**

**Responsible: Alexandra Bernard-Vidal and Almudena Sanahuja (Besançon, France)**

**Participants:**

More and more institutions are coming into contact with families and/or members suffering from their symptoms. However, as we all know, the institution acts as a mirror of the problems of the population it serves. In this sense, the care provided to these groups by a nursing team will have an impact on the psychological functioning of the institutional group. Based on these observations, the aim of this research is to propose a group projective clinic, created in the Psychology Laboratory of the University of Franche-Comté, which will make it possible to evaluate these phenomena from an objective point of view, but also to initiate group psychological work (mediation tools).

### **Research: Interventions and interpretations in couples psychoanalysis (2022-2024)**

**Responsible: Alberto Eiguer (Paris, France) Participants: Carles Pérez-Testor, Raffaele Fischetti, Lucia Balello, Deolinda Costa, Paloma de Pablos, Juan González Rojas, Ana Marques Lito, Maria Laura Diez and Amélia Pimenta (secretary).**

This research group 'Interventions and Interpretations in Couple Psychoanalysis', coordinated by Alberto Eiguer, has as members Carles Pérez-Testor, Raffaele Fischetti, Lucia Balello, Deolinda Costa, Paloma de Pablos, Juan González Rojas, Ana Marques Lito, María Laura Diez and Amélia Pimenta, the latter as secretary.

As already presented in this Bulletin, this Spanish-speaking group started in February 2022 and holds a quarterly meeting of 90 minutes, held virtually through the Zoom platform.

Since that last presentation, we have had a small number of meetings which have helped us to define the limits and scope of our objectives. Based on the subjective experience of the group, we have questioned ourselves about the symbolic value of the interventions and how they constitute a truly psychoanalytic interpretation in couple therapy. Understanding how this interpretation can awaken the work within the couple, in its intrasubjective bond, is an important issue that we will continue to develop.

The presentation of the cases that will constitute the sample of this research is limited to couples therapy, excluding simple interviews or other therapies. We are interested in studying those interventions that are situated in the psychoanalytic line. What is it that makes an interpretation analytical and produces a "mutative" effect or at least prepares for it?

However, all researchers are aware that any intervention is uncertain as to its evolution and, in particular, its effects. The temptation is often to make predictions, to underline the relevance and to insist on the strategy, although this is all the more inevitable because uncertainty is linked to countertransference and the latter reveals the fear of losing control of the process.

## Research Groups

### Choosing a relationship in later life, chapter two: between security and adventure?

**Responsible: Dina Oren (Tel Aviv, Israel) Participants : Felisa Perry - Iris Reshef Lerer , Smadar Ben Porat, Anat Ben Salmon , Miri Lange**

What is old age? It is common to divide old age into three periods: Early old age – from 65 to 70 years; Middle old age – from 70 to 80 years; Progressive old age – from 80 years to the end of life, each of which has its own characteristics.

What is Chapter Two? Chapter Two refers to a relationship in which there are no children in common and they do not form a single economic unit.

Everyone in Chapter Two experiences a break in the security of the relationship, whether through the death of a spouse or a separation. How do you recover from a relationship that has ended, how do you move on to a new relationship, and how do you have the capacity to create a stable relationship after the old one has eroded? What is a stable relationship? What are the characteristics of those who succeed and those who don't (those who reach the 'yield point')? How is the choice of spouse made the second time around? Is it similar or different from the first time? Is the choice in old age more about security and stability or about adventure and passion?

Research methodology 1. Exploratory research, 2. Qualitative research and 3. Quantitative research. In the report presented in 2024, it appears that in the study we conducted, the twelve interviewees pointed out the great difficulty of the process. Nevertheless, their motivation to seek a new relationship in old age comes from the desire to fall in love.

Falling in love can only happen if there is a split: glorifying the good and denying the less successful parts. However, in order to continue the process and build a stable and lasting romantic relationship, one needs the ability to experience things from the depressive-integrative position; to recognise that neither people nor relationships are perfect, and that the good and the bad are intertwined.

We conducted another round of interviews to further explore the interviewees' motivations for seeking a new relationship and to see how the war was affecting them.

Among the things we were told were

General things like 'I'm not in the mood, I'm worried, I'm not available to look for a new relationship' or specific and personal things like:

'The war and its hostages brought back the nightmares of my husband's kidnapping in Argentina'.

'My partner and I were planning to move in together before 7/10, but at the moment she is under a lot of anxiety and refuses to take any steps towards change'. Looking at the situation in the Middle East through Klein's positions, we can see that at the moment neither side is able to look at the situation from an integrative point of view. We hope that the regression we are in in the Middle East will also serve to develop and build new relationships.

We hope that very soon we will be able to look at the region in an integrated way and see that there are two nations in the region, both with the right to live in peace and prosperity.

## Research Groups

But let us confirm that the 'après-coup' is essential for the development of the interpretive effect: it is what allows us to integrate the novelty of the interpretive work.

For our group, it seems important to define the sample of cases that appear spontaneously in our conversation, which reveals the production of the group task. As we proposed, we avoided preparing the cases before the meeting and relied on a certain spontaneity to synchronise our latent ideas with reveries and events in the here and now.

We have discussed this methodology before, although it is valuable to remember and expand on it. We often need to redefine terms and concepts before we can use them. For example, at the last meeting a clinical case was presented of a couple who asked us about the difference between the desire to have a child and the desire to be a mother or father, and the importance of the parental/family mental space for the couple to become a family. On this subject, Alberto told us about the research of Raquel Soifer, an Argentinean psychoanalyst who studies perinatality and the impact of the birth of a child on the couple's relationship. More specifically, how and when each spouse goes from being a man to being a father and a woman to being a mother, and then how and when the masculine and feminine take their place in the relationship. Also, based on Winnicott's article on hatred and countertransference, the importance of hatred in creating ambivalence was discussed.

A theme emerges to which we can now turn our attention: the point of urgency as an object of interpretive work.

The dilemma we want to discuss today is this:

Can our research be defined as psychoanalytic research?

The collection of research material provided us with 12 texts that are by definition narrative (as opposed to argumentative or descriptive texts). They have a message, a plot, characters and a temporal element. The study of narratives can be developed in different research configurations.

The two we discussed were: phenomenological research and narrative research. We chose narrative research because we were more interested in the human experience than in the phenomenon itself. First, we analysed the text analytically, i.e. we treated the text as we would any 'cases study'. We tried to understand, through the subjective personal accounts of the interviewees, their mental experience, conscious and unconscious, as they lived it in the process of finding a partner.

The basic premise of psychoanalysis is that a significant part of a person's mental activity takes place unconsciously.

In order to better understand the causes of human behaviour, it is necessary to discover and reveal a part of the unconscious.

## Research Groups

We analyse the narratives with a narrative tool called 'selection mechanisms' (Spector-Marzel). Is this tool based on 'following the narrator'?

The premise is that the narrator, based on his life experience, chooses to tell the researcher some details and leave others out in order to convey a message.

So we followed in his footsteps and tried to identify what he said and what he didn't say, what message he wanted to convey.

We use the selection mechanism, which is a tool in narrative research. However, it has a limited purpose compared to analytical analysis.

It is a list of instructions to guide the researcher's attention while reading/listening to the interviewee.

In reality, it is only a part of the analytical analysis that is part of the conscious details.

While the analytical model takes into account everything that happens in the space between the researcher and the interviewee; feelings, thoughts and actions, the main addition is the search for the unconscious; the frame and the researcher's reactions to the interviewee's stories. (Any approach to textual analysis must answer three questions: (Gabriella Spector Marzel) First question:

What is the interviewee trying to tell me, what is the end point? Is the end point unique?

Second question:

Why: Why did the interviewees decide to tell us what they did? (In our case, the answers to this question are derived from psychoanalytic theories).

Third question:

How: how we arrived at the end point.

In our case, we analysed the text in Freudian terms, floating attention, suspended attention.

In other words, we can say that we have a psychoanalytic tool for analysing research data.

There is a psychoanalytic genre in the field of interpretive qualitative research.

It remains to be seen whether research in the field of psychoanalysis has only a single methodology or also an epistemology and an ontology?

When we ask ourselves why the interviewee chose to tell us this particular story, we look at it through analytical theories; that of Mrs. Klein and her theory of split and integrative positions, or that of Winnicott on the capacity to be alone. We are aware that attachment theory can also explain the process of searching for a new relationship from another angle, but we do not yet have enough knowledge of these theories and are therefore looking for ways to acquire it. We ask for your help in this field.

In the midst of its 15th anniversary, Poiesis Analitika has a series of initiatives conceived and planned as a celebration of its existence with those who make it up:

Associates, Associates in Training, Associations and Institutions with whom it has been in contact throughout this life journey, sharing in a healthy and fruitful coexistence.

It is in the 15th year of its existence that Poiesis launches its Portuguese Journal of Psychoanalytic Couple and Family Psychotherapy, the first issue of which is scheduled for December 2024.

It was also in this year that we launched a Research Group on Artificial Intelligence and Psychoanalysis (coordinated by Pedro Martins), as well as a series of workshops open to the public on various topics such as myths and incest/incestuality.

In 2025, she will publish a book about her story, in an autobiographical key.

This year, the results of two research groups will be published: one on Homoaffective Parenting (coordinated by Nuno Cotralha and Susana Pinto) and another on Ethics (coordinated by Rui Cintra).

Meanwhile, we have completed another year of training.

The Poiesis Training consists of a 4-year cycle and includes 4 training components:

Theoretical Seminars, Clinical Seminars, Supervision and Continuing Education.

During the course, for each year of training, study sessions are scheduled, which take place every two weeks, complemented by a conference cycle (description attached), which we open to the general public and which also take place monthly, such as the case study seminars (description attached), which are only for our trainee associates and other associates.

Applications for admission for the 2024-2025 academic year are already underway. At this stage, the number of applications has already exceeded that of the previous year, as a result of the momentum generated

We currently have 80 members. As a form of advertising, we have created a video (see attached) which, in addition to being an advertisement, contains a message and a purpose: the message that, as a group coming from different places, we are united by a feeling of belonging to a country, but also by an association whose purpose is to guarantee that

The message that as a group from different places, we are united in a sense of identity that belongs to a country, but also to an association whose aim, as a school for couple and family psychotherapists, is to guarantee this: 'Portuguese families have the right to be healthy'. Pedro Sá, member of the Board of Directors, is in charge of structuring, dynamising and facilitating the cycle of conferences (additional training).

The planning and promotion of the Case Study Seminars is the responsibility of Eugénia de Oliveira, member of the Board of Directors.

The creation of promotional content for social media (videos, posters and publications) is the responsibility of Vera Fernandes Pereira, Tresorera, member of the Board of Directors.

Manuela Porto, Helena Eirô Ferreira, Rita Paixão and Sofia Castro are the other members of a Board that is responsible for other tasks not mentioned in this brief presentation, but which are part of a working group that aims to improve these 15 years of life of an association and to provide the best way for its continued existence.

The aim of this working group, which initially consisted of 7 journals, was to support and analyse the problems of psychoanalytic publications and to help defend the space for psychoanalysis in universities. In this way, it supported the university generation, for whom articles acquire a central value in order to obtain positions. In other words, it gave young people access to a scientifically recognised publication space.

More generally, the aim of the network is to promote publications and to improve the 'visibility' of journals so that they are discovered by a larger number of readers. The publications have a double mission: that of transmission and that of establishing relationships between clinical practice, training and research.

The creation of a solidarity network has allowed us to establish links with journals that are attentive to scientific quality. The aim is to find a balance between local problems, which bring out certain themes in the publications, and the international dimension, looking for research topics that articulate the two dimensions, with the possibility of exchanging articles to be translated.

## International Journals Network

To this end, a group was set up to share experiences and difficulties faced by periodicals, and to look for alternative ways, taking into account not only the content but also the current changes in distribution methods.

The 2021 meetings led to the presentation of papers at the 2022 IACFP Congress.

A round table entitled 'Thinking about the Editorial Board', with the participation of journal directors, allowed for the presentation and discussion of tasks that illustrate the invisible and little known work of the Editorial Board, such as the disagreements that arise between the latter and the reviewers in the case of indexed journals.

The second round table, entitled 'Dialogue between authors and readers', focused on styles, the relationship between clinical and poetic experience, and possible support for writing, especially when there are obstacles in presenting the work required for certification within our associations.

Starting in 2023, this working group has planned the creation of writing workshops in each of the three official languages of the AIPCF: English, Spanish and French.

Several colleagues have experience in this type of activity and we have found it useful and enriching to propose such facilities to all the therapists in our association.

Three groups will be set up between 2024-2025 by the IACFP International Journal Network (English, French and Spanish-Portuguese), coordinated by three colleagues and between one and two observers per group, with the idea of evaluating and conceptualising the experience. The workshops will last between 4 and 10 sessions, with a limited number of participants.

A report on the work of this group was presented at the XIII Argentine Congress of Psychoanalysis - Paths of Psychoanalysis, held in the city of Mendoza on 24 May.

## CALL

The campaign for issue 31 of the *International Journal of Couple and Family Psychoanalysis* begins with the following argument:

### **“Framework, transference, countertransference and interpretation in couple and family psychoanalysis”**

From the beginning, psychoanalytic work with couples and families has differed from the traditional approach based on individual work in several crucial aspects: frame, transference, countertransference and interpretation.

Framing, transference, countertransference and interpretation are undoubtedly among the most important technical tools of any psychoanalytic practice, even with couples and families; they are the fundamental levers of the therapeutic process.

The presence of two or more patients in the consultation has made it necessary to review each of these tools from a new perspective. The framework, although confirmed in its function of stability, is increasingly seen as subject to variations that improve its function and content, in a dialectical relationship with the process.

Furthermore, following the discovery of intersubjectivity within the therapeutic neogroup, the emphasis on the interweaving of transference and countertransference, and the need for their analysis and interpretation, has become even more important. This can be useful in identifying repetitive movements in treatment as well as new elements that emerge in the course of sessions. Although much has been written about these important technical aspects of psychoanalytic work with couples and families, the aim of this issue is to understand the changes that the current turmoil in relationships implies for clinical work. At the same time, this issue aims to draw attention to the different theoretical and clinical orientations that characterise couple and family psychoanalysis throughout the world. How are setting, transference, countertransference and interpretation understood and worked with clinically in the different currents of contemporary couple and family psychoanalysis? Are they treated and understood in terms of a preferential reference to metapsychology, object relations, intersubjectivity and linking?

We hope that these questions will stimulate the interest of authors and lead them to express their views on these key elements of psychoanalytic work with couples and families.

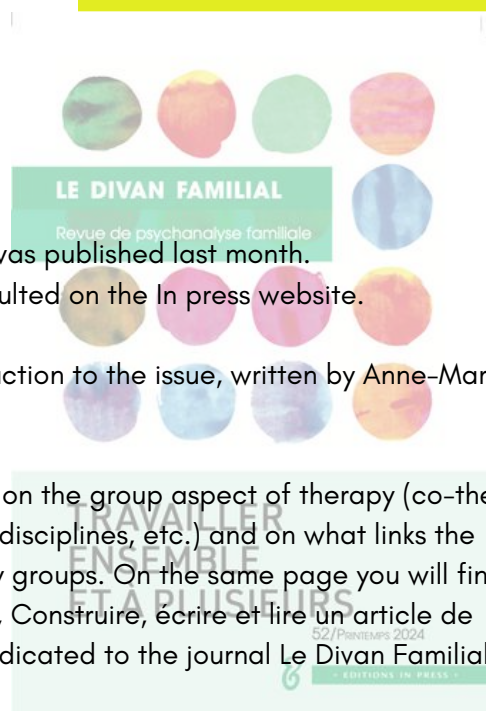

### At the same time, issue 54, *Histoires de violence*, opens with the following plot:

Violence inhabits our lives, our psyche and our society, where the spectre of the "father of the Horde" sometimes emerges. From the beginning, drives have fostered a sometimes violent encounter with objects, constituting them at the same time. They also preside over encounters with the maternal environment, which modulates their violence. Although it is not a psychoanalytic concept, the idea of violence is close to other words (aggressiveness, destructiveness, attachment and detachment, etc.) that appeal to limits and to the superego, concepts that are useful both in a theory of the ego and the object and in a theory of attachment.

Violence infiltrates all kinds of relationships: couples, families, institutions, etc. It takes many forms: physical, psychological, verbal, visible or invisible, clandestine, legitimate or illegal. What can we say, for example, about the potential violence of the State, about educators or about parents? What can we say about "positive education", which aims to eradicate violence as if it were a disease, denying its omnipresence in the family, school or care centres? A certain violence, inherent to psychological conflict, is structuring. Combined with feelings of love, it contributes to generating ambivalence, parallel to the processes of subjectivation. The place of this combination is above all the family, where the child experiences the fundamental prohibitions, and where the processes necessary for the growth of their psychic life are contained and supported. When parental functions fail, pathological forms of attachment can herald situations of alienation.

Stories of violence interrupt the therapeutic path. The system and the environment mobilise a part of the violence that passes through the transference, is deposited in the countertransference and, where appropriate, in the intertransference, sometimes seriously affecting the therapists. Identifying and analysing these processes is crucial because their emergence will also shake up the generational system, often to the benefit of the therapy. How can we avoid feeling overwhelmed and paralysed in these situations? How can we hold back and think?

The work that follows can also be detoxifying. So if, as the saying goes, 'the pen is mightier than the sword', let's get to work

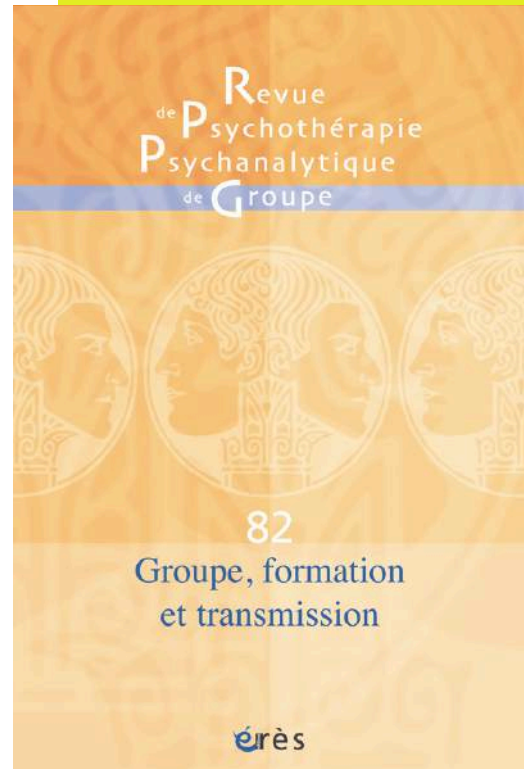



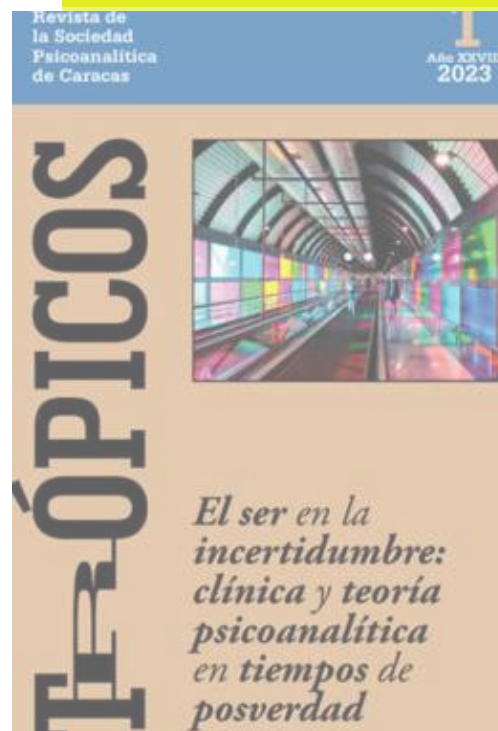

## Writing workshops in development

### Writing workshops under development

The Centre d'Études has thought about creating writing workshops in each of the three official languages of the AIPCF: English, Spanish and French.

Several colleagues have experience in this type of activity and we felt that it would be useful and enriching to propose such facilities to all therapists in our association.

Couple and family psychoanalysts, whether experienced or novice, are used to hearing and using words, both in the course of their therapies and in professional exchanges, in order to share their practice and care for that of others.

From their initial training and throughout their careers, scholarly reading provides them with knowledge and nourishes their thinking based on the theories, techniques and clinical experiences presented. We also know that daily personal writing plays a role in the maturation of clinical work, and that professional documents are also necessary in institutional work.

However, each of us may wish to go beyond the usual and express our own views on topics that have caught our interest. In this case, it is a matter of producing a work that requires the combination of several parameters: Organisation of thought is essential to the structure of a text, as is theoretical coherence and clarity of clinical presentation. Everyone has their own way of achieving this, and the whole is improved when it is expressed in polished language. In other words, writing is as much a literary activity as it is a scientific one.

Furthermore, the discussions have led us to believe that the groups would be more harmonious if they were conducted in the same language. It remains to be decided whether to opt for classic forms of writing workshops or for more experimental groups.

In Portugal, the Poiesis association already has a very advanced project aimed at Spanish and Portuguese-speaking colleagues.

Liliana Levy (Argentine Association of Relational Psychoanalysis), who has extensive experience in writing workshops, will be the facilitator of this first group.

## IACFP Conference: Violence in and on families

How can violence be distinguished from aggression and how can violence be distinguished from trauma?

Violence as a social, cultural and familial symptom will be addressed here from a psychoanalytic perspective that takes into account the concepts of bond, container, intimate, private and public. What is at stake in destructive drives is manifested in couple, family and social bonds.

As psychoanalysts and psychoanalytic therapists working with couples and families, we are confronted with suffering relationships, a clinic of invasion, control, shame and guilt.

How do we deal with and support situations of domestic and family violence, of which children are often victims?

Is it possible to understand and treat a victim without taking into account the family dynamics and the genealogical group in which the violence occurs?

Shouldn't therapeutic work integrate the various intrasubjective, intersubjective and transsubjective levels?

These therapeutic effects are mobilised within the transference-countertransference modalities. It is important to consider how the psychotherapeutic process fits into a meta-framework involving all interlocutors in the medical, social, educational, legal and judicial spheres.

The clinical aspects of psychoanalytic family and couple therapy allow us to link violence to its transmission and to its intergenerational and transgenerational repetition.

This Francophone AIPCF conference will be an opportunity to present, share, compare and challenge our clinical and theoretical experiences and reflections in a particularly troubled contemporary geopolitical context.

Le travail thérapeutique ne doit-il pas intégrer les différents niveaux intra subjectif, inter subjectif et trans-subjectif ? Ces effets thérapeutiques se mobilisent au sein des modalités trans-fero-contre-transférentielles. Il importe de s'interroger sur l'insertion du dispositif psychothérapeutique dans un métacadre articulant l'ensemble des partenaires concernés dans les domaines médical, social, éducatif, judiciaire et juridique. La clinique des thérapies psychanalytiques familiale et de couple, nous permet de relier les violences à leur transmission et à leur répétition intergénérationnelle et transgénérationnelle.

Cette journée francophone de l'AIPCF sera l'occasion d'exposer, de partager, de confronter et de questionner nos expériences et réflexions cliniques et théoriques, et ce, dans un contexte géopolitique contemporain particulièrement tourmenté.
