*They can be presented at IACFP Scientific Conferences and International Congresses, and their articles are published in our journal after submission to the Reading Committee.*

*The Study Centre of the Scientific Council of the IACFP, through its newsletter Trames, contributes to the dissemination of the scientific and administrative activities of the Association, its journal, the network of journals, as well as the various activities promoted by the Associations that make up the Association.*

*Trames is published in the three official languages of the IACFP and its editorial board is made up of representatives of these three languages.*

*For its part, the IACFP Scientific Council Study Centre contributes to the organization and distribution of the individual, collective and institutional publications of its members.*

*The Study Centre of the Scientific Council is composed of*

- a director, accompanied by a secretary, an assistant secretary and a translation assistant*
  - an editorial committee for the Trames newsletter*
  - a team responsible for the registration and distribution of the publications of IACFP members.*
- All members are appointed and confirmed by the Board of Directors for a period of four years.*

This work shows that it is possible to overcome institutional rivalry by introducing symbolic mechanisms of sharing and by adopting collaborative approaches to transform this rivalry into a driving force for innovation and research progress in our field.

Let's take a brief look at the work that has been done since its creation.

In 2020, with the support of the Scientific Council (coordinated by Carlos Pérez Téstor (Spain) and André Carel (France)) and the Board of Directors, we created a Study Centre to promote and centralize the scientific contributions of members. It was set up by Rosa Jaitin, in collaboration with Diana Hidalgo and Luisa Moi.

The aim of the Study Centre is to promote the creation of multicultural clinical and research groups among its members, with the aim of creating spaces for the production and dissemination of their scientific results in our congresses and journal. In the same spirit, we have created a College of Partners, which includes not only colleagues in training, but also colleagues interested in couple and family psychoanalysis (sociologists, anthropologists, philosophers, etc.). (Article 8 of the statutes adopted in 2020). By offering opportunities to young people and to other disciplines, the Association is raising its profile on an international level.

Within the Centre d'Études, we have revived a bibliographical updating center that was set up by Alberto Eguier (France) when the Association was founded, but which had fallen into oblivion. Today, a working committee is in charge of this task, chaired by Luis Armando Gonzales (Mexico) and Patricia Alcalde (Peru), with the collaboration of Carlos Marchese (our webmaster) and Adrián Hernández (librarian at APdeBA, Argentina). They have created a bibliographic update form for our members. You will find this form at the end of this introduction.

The creation of an international network of psychoanalytic journals has given us the opportunity to reflect on the general problem of journal publishing and to launch a writing group coordinated by Luis Armando Gonzales (Mexico) and Liliana Levy (Argentina). We have launched the project to create a writing group with artificial intelligence (2025-2026).

By investing our creative energies in our Scientific Days and Conferences, and also in the creation of the Scientific Council Study Centre, we are offering new opportunities to all colleagues by creating spaces for reflection on theoretical and clinical development.

The transmission of our knowledge is essential if we are to develop, occupy a place and maintain our identity as couple and family psychoanalysts.

Taking into account and respecting the diversity of currents of thought in couple and family psychoanalysis, our association aims to create a common framework, a working language and a language of translation to facilitate the exchange of ideas. The creation of a glossary of key words from all the currents will enable concepts to be understood in a uniform way in all languages.

Sharing knowledge across regional orientations and cultures within an international association requires an inclusive approach. By valuing diversity, using current technological tools and encouraging collaboration, it is possible to create an environment conducive to knowledge sharing that is enriching for all members. This contributes not only to personal enrichment, but also to the collective progress of the Association



Before concluding this introduction to Newsletter number 4, I would like to reflect further on the effects of current wars, mass migrations and natural disasters such as the floods in Mayotte and the fires in California. Global wars and massacres are the result of complex political and economic factors, conflicting ideologies and beliefs, and struggles for power and access to resources.

The result of all this is psychological dislocation caused by trauma, which has devastating effects on at least three to four generations, with various forms of madness in families being the result. How can we prepare ourselves in the field of mental health, both public and private?

It is up to all of us to continue to question our current context in order to respond to the new clinical challenges and to help articulate and differentiate the different orders of human reality in our work with couples and families.

I wish you an enjoyable read.

## LETTER FROM THE PRESIDENT OF IACFP

Dear Colleagues

Our association has achieved many successes in the last year: First of all, our membership has doubled thanks to everyone's commitment, and the admissions committee coordinated by Irma Morosini has worked hard to ensure the entry into our field of well-prepared colleagues. The membership fee has reduced considerably, thus facilitating the presence of many colleagues in many parts of the world.

On the scientific side, the organization of scientific days, in French, English and Spanish-Portuguese, has been launched, which can be attended in person or via links.

The French-speaking day showed a good level of clinical, theoretical and research development. The Spanish-Portuguese day will take place on 28th and 29th of March 2025 on the theme "Clinical Psychoanalysis of Couple and Family".

The English conference will focus on "Countertransference in psychoanalytic work with couples and families and in society" and is organized in collaboration with Tavistock Relationships. This conference will take place on 6th and 7th of June 2025, from 14.00 to 18.30 (CET).

The scientific committee, led by Cristina Calarasanu, is working on the preparation of the international congress on the theme "Couple and family today. Psychoanalysis in the face of new configurations", to be held in Guadalajara, with the support of the Psychoanalytical Society of Guadalajara, whose local committee is coordinated by Luis Armando González. The congress will be a hybrid event, face-to-face and on Zoom.

The Congress is scheduled to take place from Thursday, June 25th to Saturday, June 27th 2026. A closing and farewell dinner will be organized on Saturday. An accompanying group will be set up to make participants feel safe and welcome. Parallel to the congress, there will be the possibility to organize a tourist program with visits and excursions.

The Study Centre, as part of the Scientific Committee, continues its intense activity, coordinated by Rosa Jaitin, and it is to Rosa and her team that we owe the publication of the newsletter that you have already received, which reports on the life of our Association.

**I am writing to inform you that you will receive the notice of the Ordinary General Assembly and the Extraordinary General Assembly to be held on Sunday, 2nd of February 2025.**



At these meetings you will be informed about the ongoing activities and amendments will be proposed to incorporate the latest developments into the Statutes, in order to provide legitimacy to certain functions. Against this backdrop, it is proposed that the Articles of Association of our association be amended at an Extraordinary General Meeting to take account of changes in our activity.

The proposed amendments will focus on the President's role as a scientific representative and not just an administrative one, on inclusion in the statutes of the Study Centre and the newsletter, on candidates for the Administrative Council and on the documents required for admission.

## Writing workshops in development

The Centre d'Études has thought about creating writing workshops in each of the three official languages of the IACFP: English, Spanish and French.

Several colleagues have experience in this type of activity and we felt that it would be useful and enriching to propose such facilities to all therapists in our association.

Couple and family psychoanalysts, whether experienced or novice, are used to hearing and using words, both in the course of their therapies and in professional exchanges, in order to share their practice and care for that of others. From their initial training and throughout their careers, scholarly reading provides them with knowledge and nourishes their thinking based on the theories, techniques and clinical experiences presented. We also know that daily personal writing plays a role in the maturation of clinical work, and that professional documents are also necessary in institutional work.

However, each of us may wish to go beyond the usual and express our own views on topics that have caught our interest. In this case, it is a matter of producing a work that requires the combination of several parameters: Organization of thought is essential to the structure of a text, as is theoretical coherence and clarity of clinical presentation. Everyone has their own way of achieving this, and the whole is improved when it is expressed in polished language. In other words, writing is as much a literary activity as it is a scientific one.

Furthermore, the discussions have led us to believe that the groups would be more harmonious if they were conducted in the same language. It remains to be decided whether to opt for classic forms of writing workshops or for more experimental groups.

In Portugal, the Poïesis association already has a very advanced project aimed at Spanish and Portuguese-speaking colleagues.

Liliana Levy (Argentine Association of Relational Psychoanalysis), who has extensive experience in writing workshops, will be the facilitator of this first group.

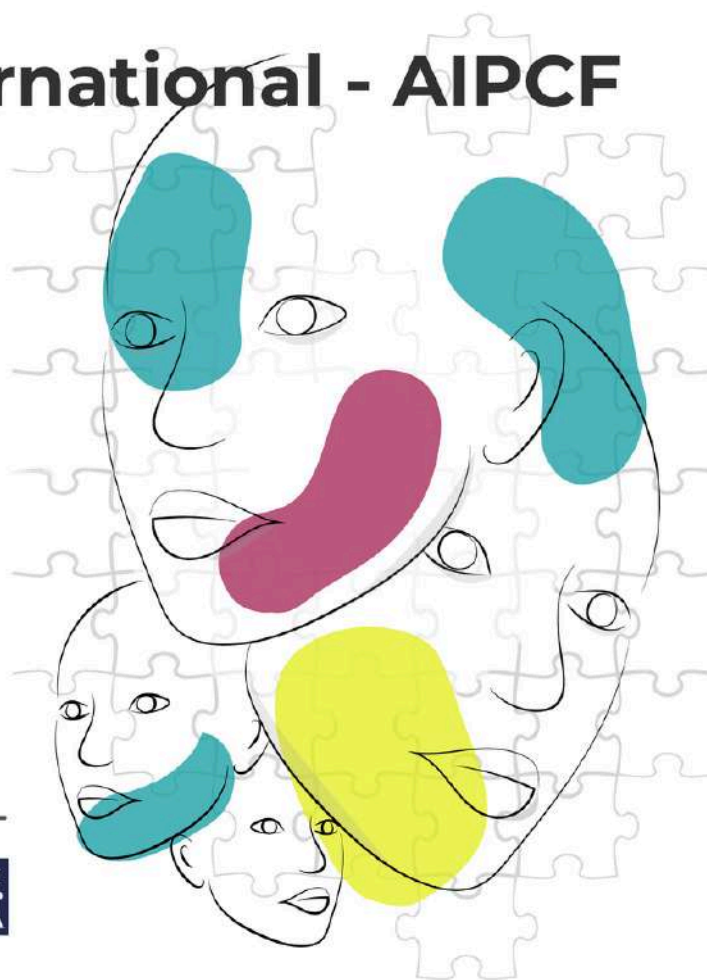

# IACFP BORDEAUX FRANCOPHONE SCIENTIFIC DAY ON OCTOBER 12, 2024

## **Violence in and on families**

**IACFP Bordeaux Francophone Scientific Day on OCTOBER 12, 2024**

**in person and by ZOOM**

This meeting was organized by the AICPF (International Association of Couple and Family Psychoanalysis) with the support of the APSYFA (Psychoanalytic Association of Family Therapists of Aquitaine) and the CTFP-GSO (Circle of Psychoanalytic Family Therapists of the Greater South-West). It took place in BORDEAUX in person and by videoconference.

After the presentation of the day by Cristina Calarasanu, it was Jean-Pierre Rosenczveig (magistrate, former technical advisor to the State Secretariat for the Family, former director of the Institute for Children and Families, former president of the Bobigny Children's Court), who opened us on Penser la violence. He took stock of justice and child protection, emphasizing that the theme of domestic violence has been emerging for some time. Violence (psychological, sexual, incestuous, etc.), which has long remained unknown, has been rediscovered by the Justice system since the 1980s, in the family, institutions, the Church, etc. Nowadays, parental authority can be withdrawn from the violent parent, due to its harmful impact on children. Local services are encouraged to support parenting, but our era of economic crisis, difficult social situations and lack of resources do not sufficiently support situations of parental failure. Abandoned to their fate, families encounter deserts for their care and the health response can only lead to many children being placed in institutions.

Let us emphasize that the reflection on the psychological effects of the immigration crisis is not sufficiently advanced. Similarly, the violence suffered or acted out for which caregivers mobilize is not brought to justice as often as necessary.

Pierre Benghozi then discussed the difference between violence and aggression, between the link and the relationship from the perspective of the psychoanalysis of links, the clinic of contents and meshes, and the transmission of shame. Relational problems are not problems of links, but crises related to filiation and affiliation. Intentional or insidious, desubjectivizing violence attacks the foundations of identity, breaks the boundaries of identity containers with disqualification, perversion, and instrumentalization. On the other hand, aggression, however horrible or transgressive it may be, aims to restore a link; it summons, challenges, and creates tension, but without breaking the link. Meta-frames, meta-containers, and meta- guarantees are spaces of protection towards security, relaunches of transmission. We also note the inadequacy of these supports in the medical-psycho-social-educational networks. After these conferences, the discussion with Christiane Joubert, returned to the difficulties and pitfalls of the implementation to listen to and help parenthood, on the collapse of meta-frameworks (Kaës), and on the difficult support, especially after a bereavement. Jeanne Cousin's book on child bereavement: Vie posthume, is quoted with a beautiful sentence that we remember "Happiness is not much; it is sorrow that rests".

# IACFP BORDEAUX FRANCOPHONE SCIENTIFIC DAY ON OCTOBER 12, 2024

The next round table concerned violence within the family and institutions. Claudine Aguesse-Viste, using the concepts of psychoanalytic family therapy, illustrated how to care for families in mediated visits. Carole Roumégous also presented the case of a family received in child protection where the child's words and the family bond were taken into account. Anne Loncan, discussant and the participants appreciated these clinical elements presented with sensitivity and precision.

After the snack break, round table 3 on couples struggling with violence was led by Anne Loncan, in place of Massimiliano Sommantico, who was unable to attend at the last minute. It included a presentation by Rosa Jaïtin on a clinical case shedding light on the construction of a couple where Eros, Thanatos and incest coexisted. Vincent Garcia then presented a case highlighting how an abused subject could become a violent spouse. The comments written by Massimiliano Sommantico on these two presentations were read by Anne Loncan and followed by discussions with the audience.

Finally, around 7:30 p.m., Round Table 4, discussed by Alain Lafage, addressed the theme: Beliefs, cultures and ideologies. But which belief should we devote ourselves to? asked Françoise Mevel in her beautiful intervention. Then Meriem Mokdad discussed the Resonances of violence within the couple, the family and society.

This French-speaking day of the IACFP was an opportunity to present, share, compare and question our experiences and our clinical and theoretical reflections, and this, in a particularly tormented contemporary geopolitical context. A social, cultural and family symptom, violence was approached from a psychoanalytic perspective where the concepts of container, intimate, private and public find a place, the issues of impulsive destructiveness manifesting themselves in the bonds of couple, family and in the social bond. Therapeutic work must consider violence and trauma, the bonds in pain, the clinic of breaking and entering, of control, of shame and guilt to accompany situations of domestic and family violence of which children are often the victims; understand and treat a victim by taking into consideration the family and genealogical group dynamics in which this violence is inscribed; integrate the different intra-subjective, intersubjective and trans-subjective levels within the transfero-counter-transferential modalities. It is important to insert the psychotherapeutic device into a metaframework articulating all the partners concerned in the medical, social, educational, judicial and legal fields. The clinic of family and couple psychoanalytic therapies also allows us to link violence to its transmission and its intergenerational and transgenerational repetition.

Overall, it was a long but rich event that took place in the afternoon and evening, between 2 p.m. and 9 p.m. Thanks go to all the speakers, members or not of the IACFP and the organizing committee: Pierre Benghozi, Cristina Calarasanu, Lucien Chomy, Rosa Jaïtin, Alain Lafage, Anne Loncan, Meriem Mokdad, Massimiliano Sommantico.

## 1. **WORKING GROUPS**

The Research Centre (EC) collaborates in the organization of research groups linked to universities and clinical focus groups in relation to the Scientific Council.

There are two types of working groups:

- The reflection groups
- The Board of Directors, in agreement with the CC and the CA, proposes the creation of a Research Centre to centralize the scientific contributions of each of its members. This research centre will encourage the creation of working groups among its members.

The Working Groups will be organized around a task defined by their own members and will elect a spokesperson who will act as coordinator of the group.

There are two types of working groups:

Theoretical-Clinical Reflection Group and Research Group. Theoretical-Clinical Groups propose group work, both theoretical and clinical, on a specific task through reflective discussion, readings, group dynamics and personal experience. In this way, members explore the proposed topic in depth and come to their own conclusions. These reflection groups require a minimum of three participants and may meet in person, directly virtually or indirectly virtually.

The focus of the reflection groups is on the task and the relational functioning of the materials to be worked on. The aim is to analyze the clinical material in terms of transference, countertransference and intertransference.

Scientific research groups are a group of people who meet to carry out research on a specific topic. They formulate objectives and hypotheses, define a scientific methodology (quantitative or qualitative) and draw up a medium- and long-term strategic plan to work on. In this way, they produce knowledge on the subject in question.

# STUDY CENTRE

A research group is made up of at least 3 people who work deliberately on a plan, purpose or agenda organized by research projects and programs for a period of time sufficient to produce knowledge outcomes.

The purpose of this work is to achieve quality results that are relevant and visible. This work aims to achieve tangible and verifiable results that meet the objectives set, as a result of projects and other research activities that are appropriately expressed in a duly formalized plan of action (projects). Each of these activities is recorded in the curriculum of each researcher and then in the research group. The results of the work of the reflection and research groups will be presented at conferences and may be published in the journal.

All IACFP members are welcome to participate in these groups and new lines of work can be proposed. Proposal for the organization of the groups by the coordinators:

Each group will hold 4 annual meetings of 2 hours each for 2 years to be presented at conferences, plan the dates of the meetings with the links and send them to the Study Centre for publication on the web.

Presentations:

Each group will present their progress at the Study Centre meetings and their overall conclusions will be presented at the IACFP International Congresses (twice a year). Partial progress will be published in the Tramas Bulletin and new members can request to join the groups of interest to them.

## 1. The BIBLIOGRAPHY

A commission, coordinated by Luis Armando Gonzalez (Mexico) in collaboration with Patricia Alcalde (Peru), has been set up to coordinate this centre.

The Commission is currently composed of Anne Loncan, Hana Salaam Abdel-Malek and Carlos Marchese, and we will add other representatives, taking into account the plurality of languages, to collaborate in the work of systematizing and updating the data. They will follow the international criteria of the APA, giving space to our members and universities.

The EC is developing criteria for the systematization of the international bibliography, organized in the form of a list of bibliographical data that can be continuously updated, taking into account the plurality of languages of the IACFP.

These working groups are set up around a specific task selected and defined by their members. This autonomy allows participants to address topics of common interest and relevant clinical challenges. Through their choice of focus, each group makes a significant contribution to research and the development of best practice in their field. In addition to the task, groups are encouraged to appoint a spokesperson to act as team coordinator. The spokesperson plays an essential role in facilitating communication and coordinating efforts within the group.

## Clinical Working Groups

### **“Relationship psychoanalysis by Isidoro Berenstein and Janine Puget” (group report 2023-24)**

The bimonthly meetings in 2023 and 2024 brought together members from 6 countries on 3 continents for fruitful presentations and exchanges.

The theoretical and clinical topics worked on were Paradigm shift with the relational and its theoretical-clinical implications, community interventions, decolonisation of the unconscious, relational complex, radical novelty.

On the singularity of Isidoro Berenstein and Janine Puget's thinking on the relational:

They make a cut, an epistemological change. No longer from the Cartesian dichotomy, nor from Newtonian physics, but from the logic of complexity, quantum physics and contemporary philosophers. Their conceptualization of the relational includes the logics of the two (representation) and the one (representation). Heterologous logics that coexist in a superimposed, discontinuous and unarticulated form, both in life and in the session.

This other metapsychology they propose requires a different clinic, with new tools such as interfering – intervening, in addition to interpreting.

Connecting means leaving the logic of identity. It is movement and production, 'becoming, becoming with others and in every situation', in continuous processes of subjectivation.

In addition, there has been work on social subjectivity, conceived as a result of the effects and impacts produced by belonging to and experiencing social-political-cultural-environmental-institutional spaces, local, national and global.

Our meetings accommodate the expression of these effects in the members of the group, who are confronted with current, shocking, confusing and disempowering situations. The Link proposes to inhabit these situations: to think and act in the present, with and among others, in the future, in fluidity. It is a work to be done as subjects in order to be able to undertake our clinical interventions.

## Clinical Working Groups

### **Threesomes: New nominations new realities. Changes in the ways of being a couple (2024)**

**Responsible:** Roberta Gorischnik (Entre Rios, Argentina)

Argument:

Trieja is a term that, as its name indicates, describes a 'couples of three'. These triads constitute a loving relationship and question the ways of doing - being in couples of the paradigm of modernity. One of the questions that guide the work is: can they be thought with other logics or do they reproduce the idea of exclusivity and belonging under the model of romantic love?

Progress:

In the course of the meetings, our dynamic is once a month and collaborative work in drive with small groups between one meeting and another. We have researched on the theoretical framework and state of the art, both existing literature and productions and experiences in the field of social (multimedia). On the other hand interviews were conducted with members of a trieja , in order to have clinical material for analysis.

Project:

To analyze the concepts and theories with which we are thinking the link configurations from the psychoanalysis, in order to problematize its logics, dynamics, meta psychological dimension etc. of the ways of doing - being in a sex-affective link that begins to be socially visible which would have instituting effects in the subjectivity, thinking in logics of social imaginary.

### **'Social work with couples and families**

### Summary of IACFP activity

We continue with the on-line group on TMF.

Since then we have been dealing with theoretical, technical and clinical aspects. During these years we have followed the methodology of presenting theoretical and clinical material for discussion at the meeting.

Professionals from Moscow, Paris, Lisbon and Bilbao continue to participate. In recent years, the number of participants from the Moscow Children's and Youth Clinic has increased (about 7 participants) and we have a translator. In total, about 15 professionals from the above-mentioned cities participate.

Our Association of Psychoanalytic Psychotherapy of Couple, Family and Multifamily Group (IACFP) completed the EU-sponsored research on 'Multifamily Groups in Mental Health', together with Italy, Portugal and Belgium. We have developed 4 products:

- A GUIDE on GMFs, with the characteristics of these groups in the 4 countries. In which we observe a clear predominance of the Garcia Badaracco model.

- A VADEMECUM on the basic concepts of Multifamily Psychoanalysis (theoretical, technical and curative).

- The COMPETENCIES that a leader of this type of group must have.

- A TRAINING PROGRAMME with three levels: facilitator, conductor and expert conductor. In addition, it is complemented by an international bibliography in Spanish, Portuguese, Italian, French, Dutch and English.

We also initiated a weekly Multifamily Community Group in the town council of Berango, Bizkaia.

### **“The impact of the epoch on subjectivity”**

We have expanded our topic of reflection from the pandemic issue to what affects us in post-pandemic times and changes the way we live.

In 2024 we closed our sixth year of work as a group composed of 14 members of various nationalities.

We hold meetings during the year to discuss the subject and share our therapeutic experiences – we have invited other colleagues to present their own experiences. At the same time we write down our ideas and share them with the aim of preparing an integrative document.

## Research Groups

### **Research: Projective tools for family and institutional groups (2024)**

**Participants:**

More and more institutions are coming into contact with families and/or members suffering from their symptoms. However, as we all know, the institution acts as a mirror of the problems of the population it serves. In this sense, the care provided to these groups by a nursing team will have an impact on the psychological functioning of the institutional group. Based on these observations, the aim of this research is to propose a group projective clinic, created in the Psychology Laboratory of the University of Franche-Comté, which will make it possible to evaluate these phenomena from an objective point of view, but also to initiate group psychological work (mediation tools).

### **Research: Interventions and interpretations in couples psychoanalysis (2022-2024)**

**Responsible: Alberto Eiguer (Paris, France)**

**Participants: Carles Pérez-Testor, Raffaele Fischetti, Lucia Balello, Deolinda Costa, María Laura Diez and Amélia Pimenta**

This Spanish-speaking research group began work in February 2022, with a working rhythm of one 90-minute meeting per quarter. The meetings were held virtually via the Zoom platform and at the time of this presentation there had been a total of 6 meetings. In the first phase of the research, the theme of interventions and interpretations in couple therapy was defined, as was the methodology for the group work, which was task-centred and encouraged the free association and spontaneity of the participants. The research group is currently consulting the bibliography on this subject, as well as sharing free association work on certain texts proposed by Alberto Eiguer and contributions of clinical case vignettes.

## Research Groups

### Choosing a relationship in later life, chapter two: between security and adventure?

What is old age? It is common to divide old age into three periods: Early old age – from 65 to 70 years; Middle old age – from 70 to 80 years; Progressive old age – from 80 years to the end of life, each of which has its own characteristics.

What is Chapter Two? Chapter Two refers to a relationship in which there are no children in common and they do not form a single economic unit.

Everyone in Chapter Two experiences a break in the security of the relationship, whether through the death of a spouse or a separation. How do you recover from a relationship that has ended, how do you move on to a new relationship, and how do you have the capacity to create a stable relationship after the old one has eroded? What is a stable relationship? What are the characteristics of those who succeed and those who don't (those who reach the 'yield point')? How is the choice of a spouse made the second time around? Is it similar or different from the first time? Is the choice in old age more about security and stability or about adventure and passion?

Research methodology: 1. Exploratory research, 2. Qualitative research and 3. Quantitative research. In the report presented in 2024, it appears that in the study we conducted, the twelve interviewees pointed out the great difficulty of the process. Nevertheless, their motivation to seek a new relationship in old age comes from the desire to fall in love.

Falling in love can only happen if there is a split: glorifying the good and denying the less successful parts. However, in order to continue the process and build a stable and lasting romantic relationship, one needs the ability to experience things from the depressive-integrative position; to recognize that neither people nor relationships are perfect, and that the good and the bad are intertwined.

We conducted a second round of interviews to further explore the interviewees' motivations for seeking a new relationship and to see how the war was affecting them.

Among the things we were told were general ideas like 'I'm not in the mood, I'm worried, I'm not available to look for a new relationship' or specific and personal things like 'The war and its hostages brought back the nightmares of my husband's kidnapping in Argentina'. 'My partner and I were planning to move in together before 7/10, but at the moment she is under a lot of anxiety and refuses to take any steps towards change'. Looking at the situation in the Middle East through Klein's positions, we can see that at the moment neither side is able to look at the situation from an integrative point of view. We hope that the regression we are in in the Middle East will also serve to develop and build new relationships.

We hope that very soon we will be able to look at the region in an integrated way and see that there are two nations in the region, both with the right to live in peace and prosperity.



## Research Groups

Let us confirm that the 'après-coup' is essential for the development of the interpretive effect: it is what allows us to integrate the novelty of the interpretive work.

For our group, it seems important to define the sample of cases that appear spontaneously in our conversation, which reveals the production of the group task. As we proposed, we avoided preparing the cases before the meeting and relied on a certain spontaneity to synchronize our latent ideas with reveries and events in the here and now.

We have discussed this methodology before, although it is valuable to remember and expand on it. We often need to redefine terms and concepts before we can use them. For example, at the last meeting a clinical case was presented of a couple who asked us about the difference between the desire to have a child and the desire to be a mother or father, and the importance of the parental/family mental space for the couple to become a family. On this subject, Alberto told us about the research of Raquel Soifer, an Argentinean psychoanalyst who studies perinatality and the impact of the birth of a child on the couple's relationship. More specifically, how and when each spouse goes from being a man to being a father and a woman to being a mother, and then how and when the masculine and feminine take their place in the relationship. Also, based on Winnicott's article on hatred and countertransference, the importance of hatred in creating ambivalence was discussed.

A theme emerges to which we can now turn our attention: the point of urgency as an object of interpretive work.

The dilemma we want to discuss today is this:

Can our research be defined as psychoanalytic research?

The collection of research material provided us with 12 texts that are by definition narrative (as opposed to argumentative or descriptive texts). They have a message, a plot, characters and a temporal element. The study of narratives can be developed in different research configurations.

The two we discussed were: phenomenological research and narrative research. We chose narrative research because we were more interested in the human experience than in the phenomenon itself. First, we analyzed the text analytically, i.e. we treated the text as we would any 'cases study'. We tried to understand, through the subjective personal accounts of the interviewees, their mental experience, conscious and unconscious, as they lived it in the process of finding a partner.

The basic premise of psychoanalysis is that a significant part of a person's mental activity takes place unconsciously.

In order to better understand the causes of human behaviour, it is necessary to discover and reveal a part of the unconscious.

## Research Groups

We analyze the narratives with a narrative tool called 'selection mechanisms' (Spector-Marzel). Is this tool based on 'following the narrator'?

The premise is that the narrator, based on his life experience, chooses to tell the researcher some details and leave others out in order to convey a message.

So we followed in his footsteps and tried to identify what he said and what he didn't say, what message he wanted to convey.

The selection mechanism, as a tool in narrative research has a limited purpose compared to analytical analysis.

It is a list of instructions to guide the researcher's attention while reading/listening to the interviewee.

In reality, it is only a part of the analytical analysis that is part of the conscious details.

While the analytical model takes into account everything that happens in the space between the researcher and the interviewee; feelings, thoughts and actions, the main addition is the search for the unconscious; the frame and the researcher's reactions to the interviewee's stories. (Any approach to textual analysis must answer three questions: (Gabriella Spector Marzel)

First question:

What is the interviewee trying to tell me, what is the end point? Is the end point unique? Second question:

Why: Why did the interviewees decide to tell us what they did? (In our case, the answers to this question are derived from psychoanalytic theories).

Third question:

How: how we arrived at the end point.

In our case, we analyzed the text in Freudian terms, floating attention, suspended attention. In other words, we can say that we have a psychoanalytic tool for analyzing research data. There is a psychoanalytic genre in the field of interpretive qualitative research.

It remains to be seen whether research in the field of psychoanalysis has only a single methodology or also an epistemology and an ontology?

When we ask ourselves why the interviewee chose to tell us this particular story, we look at it through analytical theories; that of Mrs. Klein and her theory of split and integrative positions, or that of Winnicott on the capacity to be alone. We are aware that attachment theory can also explain the process of searching for a new relationship from another angle, but we do not yet have enough knowledge of these theories and are therefore looking for ways to acquire it. We ask for your help in this field.

In this way, it supported the university generation, for whom articles acquire a central value in order to obtain positions. In other words, it gave young people access to a scientifically recognized publication space.

More generally, the aim of the network is to promote publications and to improve the 'visibility' of journals so that they are discovered by a larger number of readers. The publications have a double mission: that of transmission and that of establishing relationships between clinical practice, training and research.

The creation of a solidarity network has allowed us to establish links with journals that are attentive to scientific quality. The aim is to find a balance between local problems, which bring out certain themes in the publications, and the international dimension, looking for research topics that articulate the two dimensions, with the possibility of exchanging articles to be translated.



## International Journals Network

To this end, a group was set up to share experiences and difficulties faced by periodicals, and to look for alternative ways, taking into account not only the content but also the current changes in distribution methods.

The 2021 meetings led to the presentation of papers at the 2022 IACFP Congress.

A round table entitled 'Thinking about the Editorial Board', with the participation of journal directors, allowed for the presentation and discussion of tasks that illustrate the invisible and little known work of the Editorial Board, such as the disagreements that arise between the latter and the reviewers in the case of indexed journals.

The second round table, entitled 'Dialogue between authors and readers', focused on styles, the relationship between clinical and poetic experience, and possible support for writing, especially when there are obstacles in presenting the work required for certification within our associations.

Starting in 2023, this working group has planned the creation of writing workshops in each of the three official languages of the IACFP: English, Spanish and French.

Several colleagues have experience in this type of activity and we have found it useful and enriching to propose such facilities to all the therapists in our association.

Three groups will be set up between 2024-2025 by the IACFP International Journal Network (English, French and Spanish-Portuguese), coordinated by three colleagues and between one and two observers per group, with the idea of evaluating and conceptualizing the experience. The workshops will last between 4 and 10 sessions, with a limited number of participants.

A report on the work of this group was presented at the XIII Argentine Congress of Psychoanalysis - Paths of Psychoanalysis, held in the city of Mendoza on 24 May.

## CALL

The campaign for issue 31 of the *International Journal of Couple and Family Psychoanalysis* begins with the following argument:

### **“Framework, transference, countertransference and interpretation in couple and family psychoanalysis”**

From the beginning, psychoanalytic work with couples and families has differed from the traditional approach based on individual work in several crucial aspects: frame, transference, countertransference and interpretation.

Framing, transference, countertransference and interpretation are undoubtedly among the most important technical tools of any psychoanalytic practice, even with couples and families; they are the fundamental levers of the therapeutic process.

The presence of two or more patients in the consultation has made it necessary to review each of these tools from a new perspective. The framework, although confirmed in its function of stability, is increasingly seen as subject to variations that improve its function and content, in a dialectical relationship with the process.

Furthermore, following the discovery of intersubjectivity within the therapeutic neogroup, the emphasis on the interweaving of transference and countertransference, and the need for their analysis and interpretation, has become even more important. This can be useful in identifying repetitive movements in treatment as well as new elements that emerge in the course of sessions. Although much has been written about these important technical aspects of psychoanalytic work with couples and families, the aim of this issue is to understand the changes that the current turmoil in relationships implies for clinical work. At the same time, this issue aims to draw attention to the different theoretical and clinical orientations that characterize couple and family psychoanalysis throughout the world. How are setting, transference, countertransference and interpretation understood and worked with clinically in the different currents of contemporary couple and family psychoanalysis? Are they treated and understood in terms of a preferential reference to metapsychology, object relations, intersubjectivity and linking?

We hope that these questions will stimulate the interest of authors and lead them to express their views on these key elements of psychoanalytic work with couples and families.

# "LE DIVAN FAMILIAL"

## Life on the Divan family

Issue 53 of the magazine, entitled Famille et dépendances, was published last month. I introduced it in the introduction, which can be consulted on the publisher's website, In press Nouveautés – Éditions in Press.

If you click on the cover of the issue, you'll get further details and the table of contents will appear, followed by the introduction. The volume comprises 212 pages, 12 articles, 4 lecture notes and a film clinic note.

While other journals have opted to do away with the lecture notes, our editorial team has done its utmost to

highlight not only current works that are relevant to our theoretical and clinical concerns (L'enveloppe psychique by Denis Mellier; Le moi matière by Guy Lavallée), but also singular works that we thought it would be useful to highlight, such as Retour à Jitomir by André Sirota, Le soleil des Scorta by Laurent Gaudé, and Une famille, a film in which Christine Angot revisits her experience of paternal incest, extending her investigations to the whole of her family. All these notes were written by members of the editorial committee, showing the importance of their involvement. We are currently working on completing issue 54, 'Histoire de violences', which will be published in the spring. It will include around a dozen articles, some of which have been proposed by members of the SFTFP (Lucien Chomy, Elisabeth Darchis, Alberto Eiguier, Evelyn Granjon, Laurence Knéra); it will also welcome authors from outside our society, some of whom are new to us.

The topics covered will be varied, including several original works based on family therapies. The couple and the group are not forgotten, being present in certain articles where the theoretical component may dominate. Researchers seem to appreciate having an article published in our journal. We regularly invite them to share their clinical experiences with us, with the aim of making the process of research, which could be too dry for clinicians, more sensitive. Reading notes by Elisabeth Darchis, Didier Pilorge and others complete the issue.

Valérie Collart has joined us as a trainee member of the editorial board to help us put together DF 54. We would like to remind all members that this experience is open to everyone and that the position is vacant for DF 55. In the absence of an 'unsolicited application', we will try our luck with one or other of our colleagues, giving it some collective thought at our meetings. The presence of trainees is a source of mutual enrichment, and so far two of them (Cristelle Lebon, then Matthieu Bureau) have joined the editorial board.

A number of proposals have already been received for issue 55, Héritages. As its theme is deliberately close to that of the SFTFP conference (Incontournable transmission), we think that several contributions will be proposed by the speakers.

The argument developed should provide additional leads for those of our colleagues who are about to write. Here it is: le divan familial n° 55 Héritages

Freud's interest was captured by the relevance of this sentence from Goethe's Faust: 'What you have received from your fathers, acquire in order to possess it'.



This quotation has been used in many texts, like a leitmotif reminding us of our debts and duties. It immediately springs to mind to introduce the theme of this issue 55. But heirs are not the only ones involved in the processes of transmission and reception. As every legator is dependent on his parents and the cohort of his ancestors, we shall emphasize the phylogenetic nature of legacies which, from generation to generation and since the dawn of time, either bear fruit or, on the contrary, are depreciated,

or, on the contrary, are depreciated, lost or even disowned. Inherited goods, whether material, psychic, emotional or cultural, necessarily require the participation of the legator, but also that of the legatee, implying psychic work within the family as a whole.

The inheritance of material goods, whether movable or immovable, is not as direct and simple as one might imagine, and Beaumarchais' snarky comment to Figaro about the Count, "You took the trouble to be born", fights against the notion of any psychic work involved in the transmission. Since inheritance most often occurs after the death of a loved (... or hated) one, it is an opportunity to rekindle conflicts, as a defense to mask and postpone the mourning of the protagonists, while at the same time altering the image of the legator who has failed to organise the transmission. We know that old age and the probable proximity of a parent's death already engender ambivalent, even hostile attitudes, and mobilize sibling rivalry, where appropriate.

In situations unrelated to levels of wealth or poverty, other types of inheritance may be encountered when there is genetic transmission of an illness or disability. In such cases, parents may react by over-investing or neglecting their children. But the fault of having passed on such an inheritance generates guilt that is often concealed and a source of family dysfunction.

More subtly, but in ways that family psychoanalysts are sensitive to, family habits, rituals and myths, language characteristics and interests are passed on from one generation to the next and together define the family self. This is what accounts for the dynasties we see in the world of literature and the arts, born mainly out of the recognition of family ties and feelings of belonging.

Here are a few ideas for articles, to be submitted to the editorial team by 31 March 2025.

The editorial team will change gradually over time.

Carine Maraquin decided to step down at the beginning of November. Evelyn Granjon is now leaving us, as circumstances no longer allow her to take part in this collective work as much as she would like. Our ties of friendship, built up over many years and with many people, will remain intact.

The Scientific Reading Committee is also undergoing some changes. While in 2023 we were able to count Florian Houssier, who needs no introduction, among its members, in 2024 Patrick de Neuter has kindly agreed to join us. This is how he is presented by Editions Erès: Patrick De Neuter is a doctor of psychology, psychoanalyst, emeritus professor of psychopathology of the couple, the family and sexuality, couple therapist, member analyst of Espace analytique (France) and co-founder of Espace analytique de Belgique as well as the Centre de formation aux cliniques psychanalytiques (postgraduate certificate from the University of Louvain). For future issues and the coming year, Claudine Combier-Veuillet will contribute to the double-blind reading of articles.

Her qualifications are as follows:

Professor of clinical psychology and psychopathology. Deputy Director of the CliPsy Research Unit. University of Angers. Head of the M2 CLSF (Psychopathology, clinical psychology of the social and family bond). Co-leader of M2 PTP (Psychology of trauma, clinical pathways and contexts) & M1 PPCP.

Clinical psychologist, psychotherapist, University Health Service (SSU). These collaborations with established authors and lecturers are not only a token of recognition for the journal, but also a necessity for maintaining our journal's indexation. The opinions given to authors offer a supposedly impartial view of the texts received, complementing those of the Editorial Board. Several members of our company are on this committee:

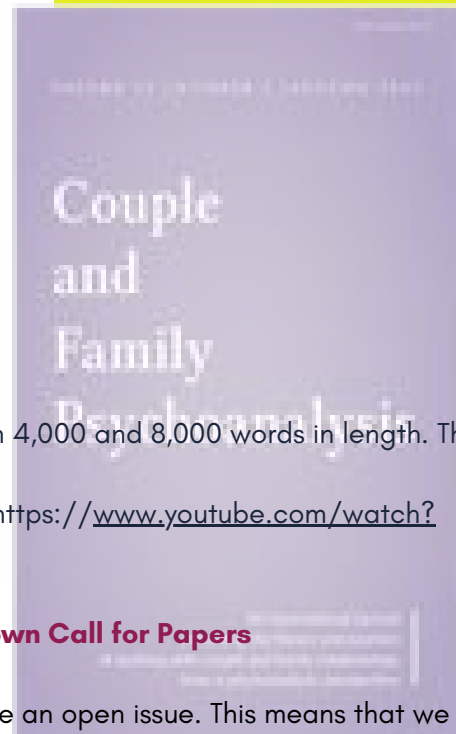

BiViPsi integrates a database that aims to preserve and disseminate the scientific production of the psychoanalytic institutions that make up the Latin American Psychoanalytic Federation (FEPAL) – International Psychoanalytic Association (IPA). It also includes and disseminates the publications of other external Psi Editors. It is also the only VHL (Virtual Health Library) in Argentina – and one of the first in Latin America – to have implemented, since 2012, the application known as iAHx for the retrieval of search results. It is an interface developed by BIREME/PAHO/WHO that displays bibliographic records in an integrated, individualized, classified and ordered way according to different criteria. It includes filters to narrow the search, organization of results by relevance, date, language and options for exporting by e-mail, among other functionalities.
