LETTER FROM THE IACFP PRESIDENT

Dear colleagues,

This newsletter highlights the intense activity that has characterised our Association in recent months. The journal has been consolidated under new leadership. Now headed by Irma Morosini, it has expanded its editorial and reading committees and has been enriched by the presence of three Editors-in-Chief, one for each language: Christiane Joubert (French), Elizabeth Palacios (Spanish), and Ludovica Grassi (English). The organisation of the next international congress in Guadalajara, chaired by Luis Armando Gonzáles, is becoming increasingly complex and detailed. Registration for the congress and submission of proposals are now open on the website.

As our Scientific Secretary, Cristina Călăraşanu, explains in this issue, the conference programme is rich and varied. Alongside psychoanalytic contributions, it will include presentations by anthropologists and sociologists.

The pre-congress day will highlight the intense activity of the study groups. A major contribution to the congress proceedings will come from the Center for Studies, currently directed by Rosa Jaitin, whose coordination fosters exchange and collaboration among the many research groups that represent the beating heart of the Association.

The Board of Representatives is resuming its activities under the attentive leadership of Patrizia Alcalde, Paloma De Pablos, Giuseppe Saraò, Hanni Shalvi Mann, and Anastasia Tsamparli.

The IACFP is not only a society of individual members but also a confederation of associations. The Board of Representatives constitutes a network of associations within the IACFP. Although its activities were unfortunately interrupted by Covid, its role is fundamental: it creates an essential network of information for the life of the Association and bears witness to the specificity of each association's orientation and training model. It also enables the unification of efforts in clinical dialogue and in defining educational standards across national associations.

This is a sensitive and important issue that has not yet been fully addressed. To explore it further, on the initiative of Cristina Călăraşanu and myself, a series of informational seminars on couple and family psychoanalysis will soon be proposed. The series will be structured around three areas: clinical, theoretical, and technical. The seminars will be conducted by psychoanalysts and psychotherapists of different orientations and in different languages. This is not a training programme, but rather an opportunity to become acquainted with and to compare different models and approaches through dialogue among clinicians and scholars with long-standing experience in the field. For this reason, the organisation of these seminars will be coordinated with national associations of psychoanalysis and family psychotherapy. Although our discipline has ancient roots, it remains relatively new within official psychoanalytic institutions. The defining characteristic of our Association—its very identity—is its ability to bring together psychoanalysts and psychotherapists with diverse models and experiences under one roof, within the same professional family.

Each day, our Association grows richer, not only in terms of membership, but also through theoretical exchange and research.

SCIENTIFIC COMMITTEE IACFP INTERNATIONAL CONGRESS 2026

Dear Colleagues,

We are delighted to invite you to participate in the 11th International Congress of the International Association of Couple and Family Psychoanalysis (IACFP) which will take place from July 22 to 25, 2026, at the Centro de la Amistad Internacional in Guadalajara, Jalisco, Mexico – in a hybrid format (in-person and online).

The theme of the 2026 Congress, “Couples and Families Today. Psychoanalysis Facing the Diversity of Configurations,” opens a space for reflection on the profound transformations of family and couple bonds in the context of contemporary socio-economic, cultural, and technological changes. The coexistence of traditional models with diverse forms of living arrangements invites us to rethink the concepts and clinical tools of couple and family psychoanalysis.

The congress will address major topics such as: the impact of cultural transformations and acculturation processes on the psyche, changes in parental functions and gender roles, new pathologies and difficulties in symbolization in an unstable world, the effects of these transformations on unconscious alliances at intra-, inter-, and trans-subjective levels, intercultural and transcultural perspectives on couples and families, current clinical frameworks for observing and working with the unconscious in relational links.

The scientific program will include 4 plenary sessions, 2 round-table debates, and thematic roundtables by language (English, French, Spanish) for participants’ presentations. One of the plenaries will be interdisciplinary, bringing together a psychoanalyst, a philosopher, and an anthropologist.

The pre-congress will be held on July 22, featuring a rich program including the presentation of the Study Center’s research and reflection groups, the presentation of the IACFP Journal, and a round table of the partner journals network.

We invite you to contribute to the scientific program by submitting an abstract (500 words) in all three official languages (French, English, Spanish), following the guidelines detailed in the Call for Papers. The accepted themes include, among others: changes in family and couple models; social and cultural transformations; migration and immigration in clinical practice; gender roles and identity dynamics; legislative and judicial frameworks in therapeutic processes; psychoanalytic techniques adapted to new family configurations. Submission deadline: January 30, 2026.

Whether you participate in Mexico or online, this congress represents a unique opportunity to exchange ideas, explore new clinical perspectives, and contribute to the advancement of a discipline essential for understanding human relationships.

We warmly invite you to register, submit your work, and take part in this international dialogue dedicated to today’s couples and families.

A Communication about the Association's Journal
Irma Morosini

Four fundamental strategies have been defined to achieve the objectives of the IACFP International Congress.

With regard to the Journal, Issue 33 is almost ready for publication on the website and is scheduled to be released on December 15. It is coordinated by Elisabeth Darchis and Christiane Joubert. This will be a particularly rich and stimulating issue, reflecting the considerable work invested by all those involved.

The issue is devoted to **Perinatality**, and its development is structured around four chapters:

- Perinatal time: crisis, transformation, and transmission
- Family history: parents, grandparents, adolescent pregnancies, family and/or couple therapy
- The suffering family body: care and support, early trauma, prematurity
- Pregnancy loss and hospital-based support programmes for families in follow-up

The issue also includes a research paper and is composed of several sections: articles (by 15 authors), a dictionary, book reviews, and tributes, as well as an introduction, a conclusion, a summary of the issue, and a review of the Tavistock Clinic Journal.

Looking ahead to Issue 34, the theme will be **Migration**. This issue will be coordinated by Alejandro Tamez and Elizabeth Palacios, who are already working on the introductory article. It will soon be available online in the appropriate section, enabling interested authors to submit their contributions. Publication is scheduled for July 2026, ahead of the Guadalajara Congress.

Within the Editorial Committee, we continue to work on several key areas, including indexing, procedural guidelines, participation in various institutional functions, the dissemination of information, and the preservation of the Association's regulated independence. The team remains committed, actively involved, and responsive.

Finally, for this newsletter, I believe it is important for the IACFP to honour and acknowledge colleagues who have passed away and whose work has left a lasting mark on psychoanalysis: Claude Nachin, Judith Dupont, Claudio Neri, and Henri Pierre Bass.

During the first half of 2025, we have been working, thinking and processing together the valuable proposals presented by several of the members for the 2026 Congress. We managed to integrate the various ideas (both in form and content) and decided to raise topics related to relational theory, its logic and founding principles at the Pre-Congress. Following a joint written document, the presentation will be in the form of a discussion.

Our bimonthly meetings have been very well attended, enthusiastic and deliberative, allowing space for debate. Some topics of discussion:

How the conceptualisations of Berenstein and Puget draw on contemporary logics from disciplines such as philosophy, physics, history, biology, sociology and others:

The logic of decentring, of multiplicity (Deleuze); the logic of indeterminacy (quantum physics; uncertainty principle); the logic of becoming; the logic of power relations (Foucault), among others. From these logics emerges the 'how to' in practice, both clinical and institutional and social, in politics, in family, group and couple coexistence.

Threesomes: New nominations new realities. Changes in the ways of being a couple (2025)

In the face of the crisis of modern institutions — among them, the couple — we question the existing forms of erotic-affective bonds that are becoming visible in today's new relational configurations, specifically those formed by three members.

From our working group, composed of professional psychologists, we have been developing a line of research framed within a psychoanalytic relational perspective. Our work focuses on the study of "triejas" (triadic relationships) as a relational configuration that challenges and questions the hegemonic conception of the heterosexual, monogamous couple — a normativized model that has been institutionalized as the only legitimate form of erotic-affective bond oriented toward the formation of a family.

This research aims to reflect on contemporary subjectivation processes and the epochal changes in how people form and experience couples and families. We consider that cultural discourses — transmitted through the social imaginary — have a profound impact on subjective constitution, especially through the transsubjective and intersubjective dimensions, as these serve as frameworks that organize what is possible and thinkable in human relationships.

Through our theoretical and clinical exploration, we seek to explain how these new relational configurations, such as triplets, not only destabilize traditional normative models but also raise questions about the ways in which subjects position themselves in relation to desire, otherness, object choice, and the formation of bonds.

“Social work with couples and families”

Testimony of clinical cases in hospital emergency care of the patient, partner and family group from a psychoanalytic perspective and its translation into medical practice.

Psychoanalysis has expanded its field of application to medicine (cardiovascular surgery, oncology, medical clinic) and, therefore, its professional practice is integrated into the hospital institution, addressing the patient, as well as their partner and family group.

The scandal of trauma and urgency creates tension and prompts us to think of new ways to respond to this subjective suffering. Illness fulfils a function, becoming the solution that the subject has found for an unbearable meaning.

The patient tempers their anxiety with the legitimisation of their organic symptom from a medical perspective and, at the same time, endorses the value of contingency from the dignity of their psychological pain.

Faced with the onset of illness and the doctor's recommendation, the imminence of hospitalisation, surgery or unexpected treatment, and even the proximity of a possible and incalculable death, patients see their routine and their very lives disrupted.

The analyst's listening and the presence of their family group promote the reconstruction of that intrapsychic object in order to reorganise subjective fantasy, sustaining a transitional state that allows the body to be revitalised, investing it with hope in the disorder, with a future and with a resilient recovery.

At the same time, the construction of a dialogue based on dialectical skill, ingenious, creative and creative exchange with the doctor, avoids disciplinary isolation and promotes the integration of our work into the institutional group, emphasising the authority of psychoanalysis and its epistemic legitimacy.

This space for exchange proposes the study of cases based on evidence and questions: What is an emergency? What does this emergency mean for the couple and/or family? How can we move from chaotic emergency to subjective emergency? as sobre lo vincular en la contemporaneidad.

Research Groups

“Research on family and institutional group projective tools” (2025) Responsible: Almudena SANAHUJA- Magalie BONNET LLOMPART.

As part of our research on family and institutional projective tools, we are developing the FAC (family helping cancer).

This research is led by Almudena Sanahuja (professor at Marie and Louis Pasteur University, Besançon, France) and Magalie Bonnet-Llompарт (professor at Marie et Louis Pasteur University, Besançon, France), whose objective is to identify the impact of the disease on the family group by studying the experience of the disease by different family members and evaluating the family structure and dynamics at different stages of the disease process (from 6 months to less than 3 years after diagnosis). In this context, projective genography and projective family espyography tools are used to study the functioning of the family group, in particular to assess the impact of the disease. The initial results have enabled us to write a first article on the traumatic effects of cancer on the patient and the family group and its members, with repercussions on the family's psychic apparatus in terms of content and container. Based on a paradigmatic clinical example, we have taken a particular interest in families committed to helping, highlighting, through the use of these family projective tools, the repercussions of cancer on the family body and, more specifically, on the “family psychic envelope”.

Research: Interventions and interpretations in couples psychoanalysis

Following the last presentation of our work in this Bulletin, this clinical and research reflection group of the AIPCF Center for Studies maintains its focus on the study of interventions and interpretations. We know that, currently, there is a great diversity of couple relationship configurations that require an approach that recognizes the complexity of verbal and non-verbal exchanges, as well as the intersubjective dimension that unfolds in the analytical space.

The analyst's words are not a neutral instrument, but an act that carries resonances, silences, and effects. The topic itself is striking in that it is both new and complex due to its very nature—that is, the analyst's own orality, their words, their doubts, their digressions, and all that this may imply. Orality becomes a space where both the analyst's unconscious resonances and the couple's urgent needs converge.

Research Groups

This topic leads us to question ourselves as couple analysts, the limits of interventions, the type of language used, from the classic modes of interpretation (structured interpretations) to the most extravagant (more creative) interventions; We are interested in continuing to think about the point of urgency as an object of work in interpretation as well as about the creative capacity of the analyst (that which breaks into the session and demands a creative response).

Interpretation can open new paths, allowing the couple to recognize themselves in their contradictions and find new ways to process conflicts. The analyst's creative capacity is fundamental to navigating the complexity of current couple dynamics and implies a willingness to listen to the unexpected in order to transform it. Interpretation is not exhausted at the moment of its utterance. The concept of après coup allows us to consider how certain statements acquire meaning retrospectively, reshaping the couple's experience over time. Even the analyst's own words, their deviations or doubts, can be subsequently reinterpreted, opening new avenues for the couple to work through their relationship.

We conclude that in our work we cannot draw definitive or overly strict conclusions; this issue eludes us somewhat insofar as the analyst's words cannot be analyzed precisely or even considered sacrosanct. Nevertheless, we find ourselves at the heart of analyzing the complexity of interpretations, a topic of modernity because it translates the sensory foundations of the language used by the analyst.

"Choosing a Relationship in Later Life, Chapter Two: Between Security and Adventure?"

We conducted an exploratory psychoanalytic-narrative study addressing "The process of seeking a new romantic relationship in later life." We interviewed 12 women and men aged between 65 and 75.

We found that, alongside feelings of difficulty and anxiety, the longing to fall in love — to feel "butterflies in the stomach" — emerged as a central motivation for remaining engaged in the search. We observed that the sensation of falling in love, which may develop from the paranoid-schizoid position, involving regression and fantasy, also serves as a platform for enhancing vitality — something particularly significant in later life. However, building a stable and lasting relationship requires acting from the depressive position.

The main conclusion of our research is that the capacity to move between mental positions creates the opportunity to find and build a new romantic relationship in later life.

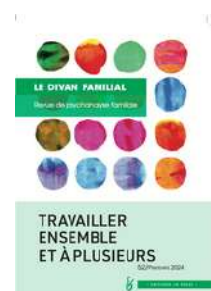

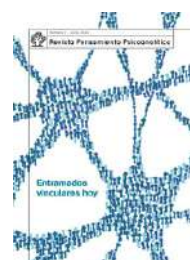

“How do we psychoanalysts take up the wealth of our inherited knowledge and put it at the service of the questions we ask ourselves each time we revisit the unease, uncertainty, and risk of experiencing the unconscious in desire, which is always determined and fertile in renewing its commitment? ...Writing is one answer.”

And this response unites us. The psychoanalyst of today faces many tasks in responding to the challenges they encounter. It is increasingly a matter of upholding principles without standardizing them, testing concepts within the new conditions of practice and culture, disseminating results, and deepening and developing research.

For this to happen, writings must not shy away from contrasts or contradictions. What kind of writing is emerging today in our psychological circles?

Beyond the publication format, issues related to genre—whether it's an essay, an academic text, or a work that intersects with other disciplines—must be taken into account. Given this range of possibilities, we sometimes encounter psychoanalytic texts in the form of essays, other times as narratives, and still other works where more dogmatic aspects predominate.

For both an author and an editorial team, understanding and thinking in terms of genres is important.

Regarding the Journal, its different sections contribute to its unique character, whether by providing space for colleagues' writings, by selecting a representative of our discipline to offer their testimony regarding their career path, or by holding an interview with a psychoanalyst who recounts their trajectory, not forgetting the space dedicated to book and journal reviews, ensuring that both national and international publications remain current. Through these sections, the Journal enables the development of a policy, a distinctive style and argumentation, as well as creating spaces for debate.

–What is the challenge today for the APA Journal of Psychoanalysis, a publication that has been around for several years, the first issue being from July 1943, with all the weight of tradition that this implies as a spokesperson and representative of our institution?

Where could we locate distinctiveness today?

Let's go over some points to identify what is distinctive

- That the writings can respond to the current times, without avoiding contrasts or contradictions
- The ethical repercussions in the digital age when it comes to writings that describe clinical practice. These repercussions raise questions whose answers are not at all simple, and demand careful investigation.
- Be aware of the editorial policies of different publications as well as the editorial policies in different psychoanalytic cultures.

It is of utmost importance to sustain exchange initiatives between publishers like these in order to face the challenges posed by the transformations that are taking place today.

Being attentive to these challenges and maintaining spaces for discussion by raising questions about what it means to publish in psychoanalysis is the best way to find increasingly better channels of communication with our readers.

To conclude, I return to the Editorial of the first issue of the magazine: "To sustain psychoanalysis in these times of transformation, to maintain the transmission of psychoanalysis, the psychoanalytic institution is indispensable.

The Journal's proposal is to provide a space that accounts for "common work". For this, institutions are fundamental, since they are the ones that ensure "a minimum of 'for all' which ultimately constitutes its reason, so that the 'one by one' of a psychoanalysis can have an effective possibility"1.

CLAUDE NACHIN

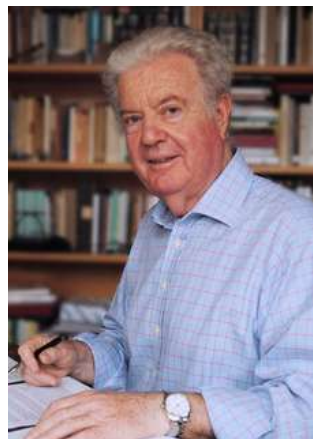
French psychiatrist and psychoanalyst Claude Nachin worked for almost 30 years as a psychoanalyst. He was one of the pioneers in the implementation of institutional therapy in France, along with Jean Oury. I had the pleasure of meeting this eminent figure in psychoanalysis during a discussion about a clinical case I presented at a colloquium organized by the Fourth Group of Psychoanalysis in Lyon. He was an intelligent, welcoming, and modest person. He was the founder of the Association dedicated to the study of Abraham Torok. He worked, in particular, on the latest advances in the psychoanalytic treatment of pathological grief and its transgenerational influences.

Italian psychoanalyst, member of the IPA, the Italian Psychoanalytic Society (SPI), and the London Institute for Group Analysis. Professor at Sapienza University of Rome. Associate Professor at the Laboratory of Clinical Psychology and Psychopathology at Lumière University Lyon 2 and at the Thema of Group, Couple, and Family Psychoanalysis at Paris 5 University. Editor of the journal *Funzione Gamma*, dedicated to group psychotherapy, and of the collection *Prospettive della ricerca psicoanalitica*, published by Borla.

Those who had the opportunity to work with him during university exchanges in Rome and at various congresses in Paris and Athens can attest to his interest in conveying his ideas and defending his positions with extraordinary clinical sensitivity.

But we also cherish the memory of his home, always open to welcome us, along with Mecha, his wife, and his playful sense of humor.
